The March for Life Conference and Expo, **formerly held at the Hyatt Regency**, will take place at the Renaissance Washington DC Downtown Hotel at 999 Ninth St. NW, and K St. NW, Wash. D.C. The Rally site is now at 12th Street at the National Mall.

Attendance at pro-life events depends on publicity. Pro-life events are listed in Life News, posted on the new LICL website prolifeli.org, and often sent by LICL to media and churches. You can play a role by attracting pro-lifers who are unfamiliar with LICL or Life News. Forward the information to a contact you know personally at your church or in your organization. Receiving the notice from a person they recognize as active in pro-life may inspire the editor to print a notice they had previously discarded. Please send at least three weeks prior to the event. For newsletters send two, even three weeks prior to the month of publication. Many pro-life, pro-family organization newsletters, each read by hundreds of members, do not include notices of pro-life events simply because no one submitted the information or the notice arrived too late to be printed. The quickest way: copy the information at prolifeli.org and paste to an e-mail. Add a line suggesting the notice be printed. Consider e-mailing as a reminder or invitation to family and friends. "No one can do everything, but, everyone can do something."
