#### PLANNED PARENTHOOD

The Planned Parenthood Federation of America recently released its annual report for 2019-2020. Planned Parenthood performed 354,871 abortions in 2019, the highest number for any given year. As the number of abortions has increased, the number of adoption referrals by PP has decreased. For every adoption referral PP had in 2019, they committed 133 abortions. Income from government sources (federal, state and local) increased \$1.3 million from the previous year. Private contributions decreased over \$81 million. Government (taxpayer-funded) monies accounted for over 1/3 of its income.

Since 2009, breast exams have fallen over 63%, Pap tests have fallen over 64%, HPV vaccinations fell over 7% and prenatal services fell over 72%. As the U.S. abortion rate is falling, the number of abortions at PP is rising. The number of abortions in the United States has fallen over 34% since 1999. Abortions at PP have increased over 94% during the same period. The share of U.S. abortions committed by PP between 1999 and 2019 has increased from 14% to about 41%.

#### **COVID-19 VACCINES**

David Prentice, Ph.D., created a COVID-19 Vaccine Chart for the Charlotte Lozier Institute (see lozierinstitute.org). The steps in the creation of a vaccine include design and development, production, and confirmatory lab tests on the product. The Lozier chart notes that the Pfizer and Moderna vaccines did not use abortion-derived cell lines in the design, development, or production stages, but did use abortion-derived cells in some of their confirmatory lab testing. The vaccines created by AstraZeneca and Johnson & Johnson used abortion-derived cell lines in the design, development, production, and laboratory testing stages.

#### FEDERAL LEGISLATION

The House passed the *Equality Act*, **HR.5**, 224-206. It would add ideological definitions of sex and gender to the Civil Right Act. **HR.5** will cover religious schools, charities, and adoptions by exempting itself from the

Religious Freedom Restoration Act (RFRA). During debate in the House on this bill, Rep. Nadler stated, "What any religious tradition describes as God's will is no concern of this Congress." Almost "any establishment that provides a good, service, program, or health care" will be a covered 'public accommodation'. Doctors will lose conscience protection, and a refusal to provide abortions will be "Pregnancy Discrimination." Reps. Meeks, Rice, Suozzi voted *yea*. The bill goes to the Senate where 60 votes are needed to pass.

HR.1319 (\$1.9T 'COVID bill') *Title X* funds are boosted \$50M, and Planned Parenthood will again have access to these funds. Senator Rand Paul petitioned the Senate Parliamentarian stating Payroll Protection Program money to Planned Parenthood would violate the Byrd rule. The House-passed version of the bill treated individual PPs as separate and distinct entities so they could apply for taxpayer funds. Before the Parliamentarian could rule on the arguments, Democrats filed an updated version of the bill that did not include the provision in order to prevent setting a precedent against PP funding. The COVID bill pays 85% of the costs of COBRA health insurance. An amendment to include those COBRA funds under the Hyde Amendment failed, so they could pay for abortions. The \$1.9T bill passed the House 219-212. [LI Democrats yea /GOP - nea]. On March 6, the Senate defeated [52-47] a pro-life amendment to apply the Hyde Amendment to the COVID bill. It failed to reach the 60vote threshold needed to waive budget rules associated with the legislation. States and localities can use the \$350 billion in state bailout funds to pay for abortions by channeling funds to Planned Parenthood if they choose.

**HR.1/S.1** [For the People Act] passed in the House 220-210. This bill contains numerous changes to voter registration and election policies. Of concern in the bill is the policy that will allow the IRS to consider the 'politics' of a group seeking a tax exemption (such as the LICL's 501(c)4 status). Ted Ellis wrote (*The Hill*, 1/21/21) that **HR.1** could "force groups that engage in nonpartisan issue advocacy, to, often falsely, declare that they support or oppose any candidate whose name appears in their materials." Donor information might also need to be disclosed. {See *www.heritage.org* for more info}

(Information on **HR.1** is provided to our readers since the voting and election process determines our ability to elect pro-life representatives, lobby for and promote prolife legislation and regulations, and protect our rights to free speech, religion, and conscience.)

#### Federal Legislation continued......

Pro-Life Legislation introduced in House or Senate:
HR.343 - States must report Medicaid funded abortions.
HR.1021 - No US funds to UN Human Rights Council.
S.99 - Life at Conception Act (under 14<sup>th</sup> Amendment).
S.139 - Defund PP Act (and other abortion providers).
S.461 - Creates 'Point of Order' v. any SCOTUS Packing.

**S.J.Res.9** - Proposes amending US Constitution to fix the number of Supreme Court justices at nine.

Seven Democrat Senators have asked for an Office of Sexual and Reproductive Health & Wellbeing. The Biden/Harris Administration would like to "codify *Roe*" into law, perhaps as a Reproductive Rights law, in the event SCOTUS overturns *Roe*.

**Confirmation Hearings:** HHS Sec. nominee Xavier Becerra could not agree with any restriction on abortion during his hearing. AG nominee Merrick Garland said his highest priority would be battling Domestic Terrorism. (Some pro-life groups have been labeled as domestic terrorists. Several years ago, he ruled to allow an abortion for a 17-year-old detained immigrant). OMB nominee Neera Tanden who helped write the HHS Mandate, has withdrawn from consideration. She is expected to get a different appointment.



#### NEW YORK STATE LEGISLATION

**NYS Right to Life says** a class-action suit has been filed vs. the Reproductive Health Act, claiming it hurts women and the viable pre-born.

NY's government is currently dominated by pro-abortion forces and pro-life legislation is likely to have a tough time passing in the near future. However, legislation is being proposed by those in the minority to advance pro-life causes:

**S.2569** *Helming* / **A.4429** *Manktelow*, the Born Alive Abortion Survivors' Protection Act (BAASPA), would reinstate and strengthen legal protections for infants born alive as a result of abortion procedures. BAASPA would require health care practitioners to ensure that any born-alive abortion survivor is immediately admitted to a hospital. The legislation would also mandate that practitioners report violations of its provisions to law enforcement. Under BAASPA, a person who takes the life of a born-alive abortion survivor could be charged with second-degree murder.

**S.2669** *Ritchie* / **A.5729** *Cusick* has been introduced, to again make attacking a pregnant woman count as two crimes in NY.

On the other side, **S.470** *Hoylman*/**A.5499** *Glick* is designed to place onerous regulations on pro-life pregnancy centers in order to limit their ability to provide pro-life solutions in crisis pregnancies.

**Pro-life LI Rep. Lee Zeldin** is mulling a run for NYS Governor.

## **HEALTH & SCIENCE**

"Plan C – The Missed Period Pill – Menstrual Regulation"



Michael Cook, editor of Mercatornet.com, wrote an article on December 7, 2020 on how the abortion industry is now promoting a new type of 'contraception' – the Missed Period Pill (MPP). During the Bangladeshi war for independence, thousands of women were raped. Abortion was illegal, so the Bangladeshi government allowed "evacuation of the uterus for a limited period – as long as the women did not have a pregnancy test. The euphemism for it was "menstrual regulation (MR)."" [Note: Plan C, MPP or MR – contain the same ingredients as the abortion pill: mifepristone and misoprostol, with the same side effects and risks.]

Cook reported the journal *Contraception* ran an article in its December 1, 2020 edition publishing the results "of a survey seeking the views of American "people" (women, presumably). The people were asked whether they would be interested in a pill which would bring on bleeding like a menstrual period, and which would terminate the pregnancy for nearly all people who were pregnant. The key point is that they would never know whether or not they had been pregnant. They found that 42% of all participants and 70% of those who would be unhappy if they were pregnant, would be interested in the MPP."

The researchers involved in the survey noted that even after so many years of abortion advocacy women are still "conflicted." A New York Times op-ed by Patrick Adams on December 3, 2020 noted, "One participant said that such a service would be "a psychological cushion" for those women "who may be unsure of their own feelings on abortion." Another said that she thought it would result "in less moral conflict," and a third that she would feel "less guilty of my choice."" The piece by Adams went on to state, "The notion behind MR - that a person wouldn't know if she had an abortion and therefore no one else could know if she did, either – is, in one sense, the antithesis of what many in the reproductive rights movement hope to achieve."

Cook noted that the authors of the *Contraception* article attribute the deep psychological suffering after abortion to stigma, not, as Cook said, "to the obvious fact that a life has been ended." The authors of the *Contraception* article acknowledged the effects of abortion: "…anxiety, stress, depression, social isolation, negative self-evaluation and somatic symptoms." Cook continued, "How can this be avoided? They have a

technology fix: by taking a pill." The *Contraception* authors concluded, "Thus, a service that enables people to ensure they are not pregnant without knowing their initial pregnancy status could have psychological and physical benefits."

The website natural womanhood.org contains a post dated 1/16/21 regarding Missed Period Pills. The post states, "In addition to the ethical concerns Missed Period Pills share with other abortifacient drugs, Missed Period Pills pose additional ethical problems for patients. First, while advocates of Missed Period Pills emphasize the convenience of sidestepping patients' concerns with abortion, there is an element of informed consent that is obscured when a patient is given a drug without full knowledge of the exact function it is completing. Also, to expose patients to side effects and adverse health effects of abortifacient drugs, when they might not even have a pregnancy to terminate, raises numerous ethical problems regarding exposure to risk. Further, the potential psychological benefits of keeping patients ignorant of whether the drug is ending a pregnancy are speculative based on patients' survey responses; it remains unclear if after taking the abortifacient the patient may feel the same mixed feelings. Past surveys have found many women want to know if their contraceptives cause abortions. Further, it's possible that some patients could later experience the mixed feelings that come with ending a pregnancy, even when a pregnancy hasn't in fact been ended."

A 2/16/21 post on the pregnancyhelpnews.com website, which is managed by Heartbeat International, noted that "While for the purposes of the study, the women were specifically told, "If you were pregnant, they [the MPP] would terminate the pregnancy in almost all women," that is certainly not how the pills are marketed. They are marketed as menstruation management, even in the title of this study; they are not marketed specifically as abortifacients...will doctors or abortion clinic workers be telling women up front that these pills induce an abortion if you're late for your period because you're pregnant? How is it fair to innocently ignorant women to shamelessly market explicitly abortifacient drugs as anything but abortifacients?" The writer explained that in her work with Option Line, she has come across many women who sincerely do not know the very basic facts concerning menstrual cycles and pregnancy. The writer asks, "How are "missed period pills" empowering to women? Marketing them preys on ignorance and exploits moral ambiguity...Additionally, women who take these pills without exploring why their period is late have not been empowered to be more informed about their body or the numerous other medical resources available to them to address the reason(s) for being late. These are real health concerns [ectopic pregnancy, PCOS, etc.], not just fear-mongering...Abortion advocates singing the praises of missed period pills and marketing them as an easy fix to a missed period does absolutely nothing to further women's quality of health care or empower them to make truly informed decisions about their fertility and family planning."

#### **GUIDELINES for PRO-LIFE PRESENCE at PRO-LIFE EVENTS and ABORTIONIST'S SITE**

All public pro-life witnessing MUST BE PEACEFUL. This is legal nonviolent direct action. Public pro-life outreach is a statement on behalf of all of the victims of abortion.

Your participation in a public pro-life awareness event or your presence at an abortion "clinic" or abortionist's office is an important affirmation of LIFE, exercise of your Constitutional right to free speech and assembly, and a witness against the tragedy of abortion. You are the face of the unborn.

Babies are dying at the hands of abortionists and their staff. Treat the site appropriately. Eating, loud talking and laughter are out of place.

- → Stay on sidewalks (public property). Do not go on the facility's property or parking lot.
- → Do not impede access of cars to/from driveways or pedestrians to doors or along sidewalks.
- Stay with a partner. Carry a camera and cell phone.
- Hold signs so they can be read by vehicle and/or pedestrian traffic. Don't wave signs in front of traffic. Hold signs tightly; larger ones should have handles or string to loop over the neck.
- Carry a pro-life pamphlet/card with pro-life assistance contact info.
- Praying, singing, and Scripture reading should be done without disturbing other pro-lifers who aren't joining your group.
- Do Not Shout at patients, workers, residents, those driving by, police, etc. Keep an arm's length away from them and step away from potential confrontations. Calling out to abortion-bound parents should be limited and done prudently; even though you're saying something positive, the stressed client may only "hear" negative screaming at her.
- Do not shadow (follow along closely) pedestrians.
- Respond to hecklers gently or not at all. Leave them with a positive life-affirming comment

Your prolife witness is seen by those contemplating abortion, those who know or will know someone with an untimely pregnancy, and those hurt by a past abortion decision. Your presence is critical in keeping the plight of the unborn on the public conscience and saving lives.
