## FEDERAL LEGISLATION

On Nov. 2, President Obama signed the 'Continuing Resolution', which he says "locks in" federal spending for the next two years. This means most current programs will not change during that time. Trying to make some pro-life changes, the House, on Oct. 23, passed HR 3762, a "fast-track reconciliation" bill, by 240-189. {Yea- Zeldin, King, Nay - Israel, Rice, Meeks}. The "fast-track reconciliation bill" would defund Planned Parenthood for one year, end ObamaCare's HHS Mandates and the Independent Payment Advisory Board (aka 'death panel'), and send an additional \$235M to ObamaCare Community Health Centers. (These centers can be non-aborting alternatives to PP).

Fast-track' bills need only 51 votes to pass the Senate. The Senate vote was expected the week before Thanksgiving, after this issue went to press.

Pres. Obama has promised to veto any legislation that would defund Planned Parenthood or hold it criminally liable for harvesting aborted babies' body parts if they are still alive. (lifeneews.com, 11/5/15)

Newly elected Speaker of the House Paul Ryan said in a 2012 radio interview (Mark Levin, 7/11/12) that 85% of Obamacare could be defunded via 'reconciliation'. However, recent reports indicate that Cong. Ryan says only a few percent could be defunded by that procedure.

On Oct. 13, PP said it will stop accepting any money for fetal parts, even though the law allows them to recover "reasonable expenses" for prepping the "tissue." PP has spent \$600K to fight Congressional defunding. (lifeneews.com)

LifeNews.com reported on 11/5/15 that Congresswoman Nancy Pelosi appointed 6 Democrats to the Select Panel on abortion and the sale of aborted baby body parts. This committee will spend a year thoroughly investigating the PP abortion business amid the scandal of it selling aborted baby body parts and the possibility that it violated multiple federal laws in so doing. These six representatives received over \$43,000 from PP during the 2012 and 2014 election cycles alone. Eight Republicans are also on this Committee, led by Rep. Marsha Blackburn. She announced that the committee will investigate:

1) Medical procedures and business practices used by entities involved in fetal tissue procurement,

2) Any other matters with respect to fetal tissue procurement,

3) Federal funding and support for abortion providers,

4) The practices of providers of 2nd and 3rd trimester abortions, including partial birth abortion procedures that may lead to a child born alive as a result of an attempted abortion,

5) Medical procedures for the care of a child born alive as a result of an attempted abortion, and

6) Any changes in law or regulation necessary as a result of any other findings made.

The Supreme Court announced on Nov. 6 that it will hear the case of the Little Sisters of the Poor and 6 other cases challenging the HHS abortifacient/sterilization/contraceptive Mandate. This is the 'final step' of the Sisters' case. Court watchers expect a general ruling on religious non-profits vs. the mandate this term. Also, a suit expected to end at the Supreme Court has been filed by several States vs. an ObamaCare fee which the IRS collects (if the States want to continue to receive Medicaid money).

**NOTE:** LICL objects to ObamaCare because parts in it include abortion coverage & abortifacient/sterilization/contraception coverage at taxpayer expense, and direct or implicit limiting of care to vulnerable populations such as sick newborns and terminally ill.

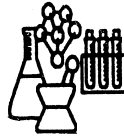

### Human Exploitation



The lead story in the Sept/Oct 2015 issue of the Population Research Institute [PRI] Review asks, “In China they eat babies; Planned Parenthood kills them and then sells their organs. Which is worse? In some exclusive Chinese restaurants is an item that goes by the name of spare rib soup. Very expensive, it is usually served only in the back rooms to known customers, who are willing to pay a premium for this delicacy...Spare rib soup is actually a human soup, made from the bodies of aborted babies. It is regarded by the Chinese – at least some Chinese – as a rejuvenating potion. A kind of fountain of youth that will fix sagging wrinkles, grow back missing hair, and generally put a spring back in your step. All of which is quite simply nonsense.”

The authors, Steven Mosher and Jonathan Abbamonte, question how Dr. Deborah Nucatola, Senior Director of Medical Services for Planned Parenthood, “can manage to keep down her lunch while casually revealing that she did a ‘seventeen weeker just this morning’.” (From the videos released by the Center for Medical Progress [CMP].) Commercial trafficking of fetal tissue for profit is prohibited by federal law. Nucatola states that PP abortionists “want to come to a number that doesn’t look like they’re making money.” The PRI Review article explains that Nucatola also said in the video that abortionists “sometimes do a manual version to keep the baby’s head intact so it can be sold.”

A second article by Jonathan Abbamonte in the Sept/Oct 2015 PRI Review is titled “Planned Parenthood uses manual vacuum aspirators to harvest fetal organs.” The second video released by CMP contained footage of Dr. Mary Gatter, a senior executive of PP, saying, “I wouldn’t object to asking Ian, who’s our surgeon who does the cases, to use an Ipas [manual vacuum aspirator] at that gestational age in order to increase the odds that he’s going to get an intact specimen.” Abbamonte explains that manual vacuum aspirators “are murderous machines used to abort babies between 3 and 14 weeks gestation. They are large, unsophisticated syringes operated by hand that work by suctioning the fetus from the mother’s womb...Manual vacuum aspiration [MVA] uses less suction than electronic vacuum aspiration [VA], perfect for preserving more organs intact for harvesting... MVA devices are used often in developing countries because they can be used without electricity. Since MVA devices require little training to operate, they are often used by non-physician abortion providers. Their small price tag and portability allow them to be widely distributed in remote locales, often in areas with poor sanitation and poor healthcare...Unsterilized

reusable MVAs have likely contributed to the spread of AIDS in Africa and STIs (sexually transmitted infections) worldwide...PP would stand to benefit financially from switching from VAs to MVAs. VA equipment is far more expensive than MVA devices...MVAs can be done in the doctor’s office...Alisa Goldberg, MD, concludes her study comparing MVA and VA procedures by saying... “purchasing an electric vacuum machine requires a large initial investment... [the lower cost of MVAs,] together with the simplicity of use could increase the number of physicians who offer abortion to their patients in an office setting.”

Abbamonte also notes that MVA devices are not subject to FDA approval. Ipas, the lead manufacturer of MVA devices, is not a pharmaceutical or medical device company, but rather an international abortion advocacy organization. PP is one of Ipas’ leading donors. Abbamonte concludes, “Americans should not be forced to subsidize an organization that sells fetal body parts for profit and procures late term abortions... Dr. Gatter can be seen at the end of the video bartering for maximum profit while settling on a price that doesn’t look suspicious... [she states],...“if it’s still low, then we can bump it up. I want a Lamborghini.”

Dr. Theresa Deisher, President of Sound Choice Pharmaceuticals, states in their Fall 2015 Newsletter, “Human exploitation goes beyond the harvesting of the bodies of aborted babies. Eggs for cloning research are pilfered from poor and vulnerable women; organs for transplantation are stolen from refugees and impoverished villagers and appropriated from prisoners harvested at their executions. A mission of Sound Choice and all our supporters is to shed light on these barbaric and archaic practices...We must bring our alternatives to clinic [sic] to stop the funding of PPs harvesting of human bodies and the exploitation of other human beings in the quest for biomedical progress...the public is becoming aware of the overwhelming advantage of adult stem cells over embryonic or aborted fetal stem cells...There are now 14 FDA approved adult stem cell products and over 450 clinical trials worldwide [using adult stem cells] ...AVM Biotechnology has a lead molecule that [makes sure adult stem cells work their very best]...All vaccines are, have been, or can be produced using ethical alternatives...Alternatives are not just ethical, they are safer as well...and are also more affordable.”

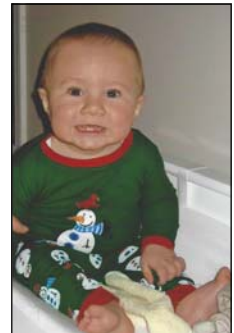
