

#### Writers for Life

We thank all of you Pro-Life supporters who write letters to the various publications, and congratulate the following writers, **Rich Gartner**, whose letter appeared

in *The Northport Observer*, **Jill Wrubel**, whose letter appeared in *The Smithtown News*, **Mary Grace Lynch** and **Dr. Paul Carpentier**, whose letters both appeared in *Newsday*. We encourage everyone to keep writing those pro-life letters, and send us the clippings with the name of the publication of any prolife letters you see in print.

#### FEDERAL LEGISLATION

On June 4, the day of the March4LifeNY, the US Supreme Court ruled 7-2 in favor of baker Jack Phillips in Masterpiece CakeShop v Colorado Civil Rights Commission. "The neutral and respectful consideration to which Phillips was entitled was compromised here," they said.

Ginsburg and Sotomayor dissented. Radio host Mark Levin noted, "...this opinion is specific to this case, these facts... they're not settling a constitutional matter." Many similar cases await Court review.

Also on June 4, the Court threw out, unsigned and with no dissent, Azar v Garza. Thus, SCOTUS said Jane Doe, and all unaccompanied alien minors in government custody, do not have a right to be provided with an abortion. However, the Court dismissed the government suit vs. the ACLU for taking the first Jane Doe for her abortion earlier than expected. Other pro-abortion 'Jane Doe' suits continue in courts.

As we await the NIFLA v. Becerra decision, HHS's Office of Civil Rights is investigating California and Hawaii for forcing pregnancy centers to promote free abortions. California insurers must cover most abortions.

A 2015 Arkansas law, requiring doctors who dispense abortion pills to have admitting privileges, or partner with a doctor who does, will take effect in mid-July. On May 29, SCOTUS rejected without comment a PP challenge of the law. Two days later PP began cancelling appointments at its two Arkansas facilities, leaving one abortuary in the state. PP will fight on in lower courts, and will restart abortions, if they find OB/GYN partners.

In mid-May, the Administration modified the *Title X* Family Planning program with the Protect Life Rule. It requires strict monetary and physical separation of abortion services from 'family planning' services. No longer must abortion always be offered as a family planning option, and natural family planning can now be included. Planned Parenthood could lose \$50M - \$60M in taxpayer funds. Similar regulations were upheld in 1991.

On May 30, the President signed **S.204**, the *Right to Try* Act. It gives terminally ill patients, who have exhausted conventional treatments, easier access to experimental drugs. It reduces the legal culpability of health providers.

Sec. of State Pompeo announced he will personally host the first international "Ministerial to Advance Religious Freedom" in DC in late July. Faith leaders & diplomats will discuss "concrete ways to push back against persecution..."

The UN Office of the High Commissioner for Human Rights has debuted a new Ad Campaign with the message "you have human rights since birth." This is clearly at odds with the Convention on the Rights of the Child, and other international treaties. On May 1, the US State Dept. cut the term "reproductive rights" from its annual human rights reports. In early June, came new International Law Commission guidelines on how to define 'customary international law'. The changes will make it easier for pro-aborts to claim abortion is now a recognized 'international human right'. (See: C-fam Jun 4)

On May 4 the Gov. of Iowa signed a 'heartbeat' (6 wk) abortion ban. Iowa's AG declined to defend it, and PP sued. On June 1, an Iowa judge blocked the law.

Federal Legislation continued.....

On May 16, California Judge Ottolia ruled the State's End of Life Option Act was improperly passed by special session. On May 30 he refused to vacate that decision.

Ireland voted to drop its Life-protecting 8th Amendment by a 2 to 1 margin. Parliament could formalize the repeal by the end of the year. Exit polls said 52% want abortion generally available up to 12 weeks. 77% said their vote was influenced by 'hard case' stories (rape, incest, fetal deformity or life/health of the mother). Irish pro-lifers vowed to fight on, citing social media censorship, celebrity endorsements, 'flyin' voters, foreign (US) money, the Church sex scandals and a cultural change to secularism as reasons for the loss.

Red Rose Rescuers: Rescuers were told (unofficially, by the police) that charges were dropped because their case was similar to a recent case where a man used an illegal handgun to save a child from a dog attack. No gun charges were brought. It would seem a "defense of necessity" was recognized for the Rescuers actions. (IF that was the reason.) Other Rescuers who entered the same Washington DC 'clinic' last Dec will be in Court June 25.

A suit by undercover videographer David Daleiden, to lift the gag order on some of his tapes, was thrown out by the 9th Circuit Court. David claimed the order violated a law to guard free speech from threats by frivolous suits. Live Action released a video showing PP covering up child sex abuse, including statutory rape.

The following three pro-life bills have passed in the House, but await action by the Senate:

HR.7/S.184, No Taxpayer Funding for Abortion Act HR.36/S.1922, the Pain-Capable /20-week abortion Ban. HR.4712/S.220, the Born-Alive Abortion Survivors Protec-

The House has yet to act on HR.644, the Conscience Protection Act.



## **NEW YORK STATE** LEGISLATION

The NYS Senate Health Committee voted down an abortion expansion bill. NYS Sen-

ators may try to bring abortion expansion to NYS through last-minute hostile amendments during the last few weeks of the legislative session. These amendments would eliminate restrictions on late-term abortion, allow non-doctors to perform abortions, and remove protections against unwanted or coerced abortions. Attempts by abortion advocates to force a floor vote on the Comprehensive Contraception Care Act and the Reproductive Health Act have failed as of our printing deadline. The voting margin is razor thin, with the possibility of Lt. Gov. Hochul casting a tie-breaking vote. The session is scheduled to end June 20th. Hopefully, by the time you read this, Life will have prevailed.

The Assisted Suicide bill remains in Committee. All bills will have to be re-introduced and assigned new numbers in the January 2019 session.

## **HEALTH & SCIENCE**

## Science and Technology, Human Rights, and Personhood



The Atlantic.com issued an article by Emma Green entitled "Science is Giving the Pro-Life Movement a Boost" on 1/18/18. Green reported that pro-life activist Ashley McGuire acknowledged that "technology has defined her pregnancies...from the apps that track weekly development to the ultrasounds that show the growing child." McGuire stated, "My generation has grown up under an entirely different world of science and technology than the Roe generation. We're in a culture that is science-obsessed... The prolife message has been, for the last 40-something years, that the fetus...is a life, and it is a human life worthy of all the rights the rest of us have...That's been more of an abstract concept until the last decade or so, [but] when you're seeing a baby sucking its thumb at 18 weeks, smiling, clapping, [it becomes] harder to square the idea that that 20week-old, that unborn baby or fetus, is discardable." Green pointed out that when *Roe* was decided, viability was about 28 weeks. Medical advances have brought it down to about 22 weeks. The author acknowledged that "these advances fundamentally shift the moral intuition around abortion. New technology makes it easier to apprehend the humanity of a growing child and imagine a fetus as a creature with moral status." Ms. Green pointed out that in the past, abortion activists "claimed science for their own side. The Guttmacher Institute, a research and advocacy organization that defends abortion and reproductive rights, has exercised a near-monopoly over the data of abortion...The idea that life begins at conception "goes against legal precedent, science, and public opinion," said Ilyse Hogue, the president of the abortion-advocacy group NARAL Pro-Choice America ... Members of the pro-life movement are "not really anti-abortion...They are against [a] world where women can contribute equally and chart our own destiny in ways our grandmothers never thought possible.""

Green points out that both sides have used science as their 'ultimate tool'. But recently "pro-life activists have been more successful in using that tool to shift the terms of the policy debate. She stated that some pro-lifers "warn that overreliance on scientific evidence could erode the strong moral logic at the center of their cause." There is also the danger of research being 'weaponized' and used for political purposes.

Neonatologist Colleen Malloy cited the contradiction of doctors spending so much time and money to deliver and care for premature babies while supporting abortion: "The more I advanced in my field of neonatology, the more it just became the logical choice to recognize the developing fetus for what it is: a fetus, instead of some sort of subhuman form. It just became so obvious that these were just developing humans."

Green noted that Planned Parenthood treats abortion as a 'gynecological or health-care service. Ashley McGuire commented that "Science for science's sake is not necessarily good. If anything, that's what gave us abortion...

When the moral and human ethics are removed from it, it's considered a medical procedure." Former NARAL president Kate Michelman admitted in a *Newsweek* article in 2010 that "technology has clearly helped to define how people think about a fetus as a full, breathing human being." Jeanne Mancini, president of March for Life said that abortion advocates have, for the most part, stopped referring to a fetus as a 'blob of tissue'. She stated that it's hard to say it's not a baby when you can hear a heartbeat and see hands moving.

Notre Dame Professor O. Carter Snead reflected, "The pro-life movement has always been a movement aimed at cultivating the moral imagination so people can understand why we should care about human beings in the womb. Science has been used, for a long time, as a bridge to that moral imagination."

Anthony McCarthy, editor of the newly released book Abortion Matters, wrote at LifeSiteNews.com on 6/7/18, "The question whether I was indeed a fetus is one any thoughtful person will want to consider when reflecting on abortion. Am I the same living being as the fetus, and if so, did I always have my current moral right not to be deliberately killed? ... The following is undeniable: At... conception a sperm from my father fertilized an ovum of my mother. Although containing DNA from both my mother and my father, the new living being was genetically distinct and not part of either parent, still less a part of both. Nor did I behave like a part of either parent, but rather behaved like what I was: an entirely new living entity whose functioning was directed toward my own welfare and survival, interacting harmoniously with the support my mother provided until I was old enough to be born. If we watch the development of that living being, gradually forming into a fetus, neonate, toddler, adolescent and adult, we see a continuous development. There are no breaks...we are human beings capable of great evil and injustice...morality is about making choices which respect the flourishing of all human beings and not just of some... whatever the 'lines' (in fact smooth gradations) between stages of human life, that life is in every sense the life of a human being. Once we realize that, we get a better sense of what kind of life should go with that recognition."

A video by the organization Choice42 (Choice for Two) has gone viral. Calvin Freiburger wrote at LifeSiteNews.com on 6/5/18 that the video uses "humor to dismantle the logic of pro-abortion claims that babies do not have human rights until after they are born. Laura Klassen "satirically explains how the 'magical birth canal' confers human rights on a baby upon birth. She says, "But as it passes through the birth canal, something amazing happens that transforms it into a person with human rights." In another video Klassen stated, "Though legally it's a woman's choice, she's choosing for two. She's deciding the path her own life will take, but she's also deciding whether or not her pre-born child will even get his/her chance at life."

- By the 11th and 12th weeks I am moving my arms and legs, sucking my thumbs and breathing amniotic fluid. All my systems are working.
- My movements by 16 weeks are quite active and I can be seen performing somersaults on ultrasound but am not yet felt by my mother.
- From the 3rd month on nothing new develops. I continue to grow in size and by 20 weeks I have hair on my head, weigh I pound and am 12 inches tall.
