FEDERAL LEGISLATION

None of the pro-Life or anti-Life bills in Congress have made any significant progress since last month.

HHS Mandate - the Federal

government, on 2/12/14 announced its intention to appeal Judge Cogan's ruling of 12/16/13, in the case *Catholic Archdiocese of New York v. Sebelius*, which gave Catholic Health Services of LI, and other NYC area Catholic organizations, temporary protection from the HHS Contraceptive/Sterilization/ Abortifacient Mandate. As of 3/31/14, the Federal appeal has not been filed. On 3/25/14 the U.S. Supreme Court heard the cases of *Hobby Lobby & Conestoga Wood* v. the HHS Mandate. Decision expected in late June. **Both plaintiffs say some of the mandated products may cause early abortions.**

NOTE: The LICL opposes the anti-Life parts of Obama Care, but takes no position on the Bill as a whole.

NEW YORK STATE LEGISLATION

Long Island Is Key- According to a 3/31/14 Newsday article, Long Island is key to controlling the State Senate, as several seats are up for grabs and some "safe" seats have now become competitive. It is our responsibility to be vigilant and supportive of candidates who share our views. It requires activity on our part, to stay informed; social media is a great way to do this. You can follow on Facebook, NYS4Life, or nyscatholicconference. Let those who stand with us in Albany know you stand with them! They need your support and encouragement more than ever, as the enemy has become more aggressive these past few years.

Oppose Abortion Expansion-Despite a great victory in 2013, the pro-life community in New York must remain vigilant and continue to educate and mobilize against abortion expansion. In 2013, a hostile amendment to bring the Abortion Expansion Act to the Senate floor for a vote was defeated by only one vote!

A 4/7/14 E-Mail from NYSRTL Committee cautioned: Unlike last year, the battle is being conducted quietly. It appears Gov. Cuomo does not want a lot of attention to this issue because this is an election year--but just as the Women's Equality Act was brought up very late in the session last year, (6/23/13), the same thing may happen this year and we have to be ready.

<u>ACTION:</u> Visit or contact your Senator (contact information below). Urge he/she oppose abortion expansion in NYS as part of the 10-point "Women's Equality Act" or as standalone legislation. Distribute the "Oppose Abortion Expansion" petitions (see pg. 1).

Support the Sex Selection Abortion Ban (S.2286/A.2533)

ACTION: Contact your Senator and Assembly Member to co-sponsor the Sex Selection Abortion Ban. Sex selection kits are sold at some drug stores Check yours and take a picture to show your legislators--and point out that this is the real "war on women" since most sex selection abortions kill girls.

HEALTH & SCIENCE POLST Warning

POLST stands for 'Physician Orders for Life-Sustaining Treatment'. A publication distributed by the Pro-life Healthcare Alliance (PHA) entitled "Informed, A guide for critical medical decisions," warns of the dangers of a POLST. It contains the following comment by E. Christian Brugger, PhD, "The POLST is a living will on steroids...The real danger is that people who sign a POLST often don't understand how powerful this instrument can be."

The publication states that "Trained 'facilitators' usually not physicians - ask patients questions about their treatment wishes and check boxes on POLST forms that correspond to patient responses. POLST protocols or laws require a healthcare professional's signature, but the patient's signature and witnesses often are not required or sought, which is quite the opposite of Living Will requirements. Without the patient's signature or impartial witnesses, how can anyone be certain that the POLST expresses the actual wishes of the patient and that he or she was not coerced or manipulated, or was even competent to make medical decisions when the form was filled out? After filling out a patient's POLST form, the facilitator presents it to be signed by a physician or other designated healthcare professional someone who may never have seen or talked with a patient. Once signed, the brightly colored POLST form becomes the very visible first page of medical orders in the patient's chart. It indicates whether to withhold or administer cardiopulmonary resuscitation (CPR), antibiotics, and/or assisted nutrition and hydration, and also whether the patient should receive 'comfort measures only,' 'limited additional interventions,' or 'full treatment.' POLST restrictions apply the instant the order is signed, whether or not the treatment is associated with an end of life condition. POLST medical orders travel with a patient from one healthcare setting to the next and even home to be followed by EMTs in an emergency. The first order in many POLST forms is 'FIRST follow these orders, THEN contact Physician.' It is always best to make medical decisions 'in the moment,' that is, based on the patient's current situation. Using medical orders that were written weeks, months or years earlier is not sound medical practice."

The publication goes on to warn that a POLST form "may render the agent you appointed in your Durable Power of Attorney for Health Care (DPAHC) powerless to protect your rights. If a POLST form and an advance directive conflict, the latest (usually POLST) often prevails, even if you (or your agent) did not sign the POLST...POLST is not needed for treatment to be provided. A typical POLST form states, 'Any section not completed implies full treatment for that section.'

Therefore, filling out a POLST form if you want full treatment is unnecessary...The PHA advises you to refuse to answer POLST questions and to warn your loved ones, as well. No matter how many times you are approached by POLST facilitators, firmly state, "I have a Durable Power of Attorney for Health Care which will go into effect if ever I need my agent to make decisions for me. Until such time, I want to discuss my current and future medical conditions and applicable treatment and care options with my attending physician and no one else. Please respect my wishes.""

The publication also warns that Living Wills can be dangerous: "In a Living Will, you request or refuse life-sustaining treatment for some future illness or injury based on pure guesswork. Also, when hospitalized, your attending physician may be a stranger who does a poor job of interpreting your wishes, particularly if they do not share your values. Worse yet, a physician can be disciplined for failing to comply with your Living Will's refusal of treatment unless the physician attempts to transfer you to a physician who will comply. Therefore, a Living Will may tie the hands of a physician who values your life and whose skills could restore you to health."

The Pro-life Healthcare Alliance recommends a Durable Power of Attorney for Health Care. You appoint an agent (a family member or friend) - someone you trust to make decisions for you when you are unable. "Your agent will endeavor to honor your values while basing decisions on current information (your condition, treatment options, likely outcomes, etc.) provided by medical professionals...It is wise to choose someone who (1) genuinely respects human life and is capable of making morally sound medical decisions for you, (2) will ask questions in order to base decisions on the best medical information and advice available, (3) will not be easily intimidated by medical professionals or terminology, and (4) will obtain a second opinion or legal advice if necessary. Discuss your wishes with your agent when you sign your DPAHC and periodically thereafter, as your circumstances and perspective may change over time. A DPAHC is essential for anyone who is 18 years or older. To be certain that a person you trust will make medical decisions for you if you become incapacitated, you must specifically name that person in a legal document."
