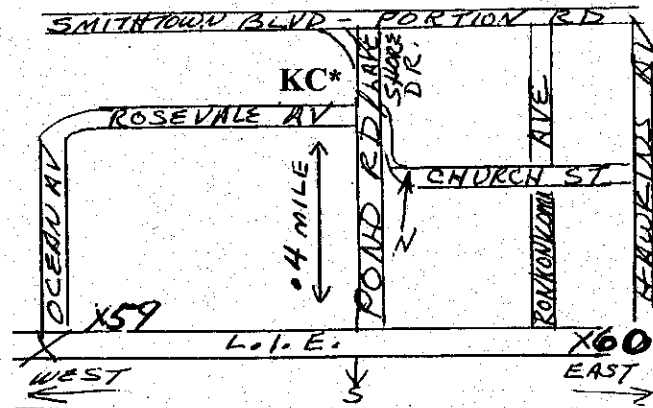

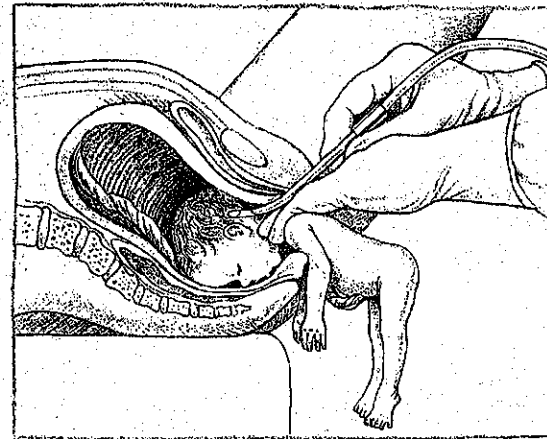


## Planned Parenthood - The World's Largest Killing Machine.

The International Planned Parenthood Federation (IPPF) likes to portray itself as a kindly, benevolent organization concerned only with the "health" of women.

But in reality, IPPF is the most wicked organization on earth. Here are some facts you might not know about the International Planned Parenthood Federation:

- In the U.S., with more than 800 clinics, Planned Parenthood is a front-line defender and practitioner of "partial birth abortions" — an absolutely gruesome procedure in which all but the head of a late-term baby is removed from the mother. The baby is then murdered when the abortionist punctures the child's skull and literally sucks out the infant's brain. (see diagram)
- Throughout the world, the International Planned Parenthood Federation teaches children that it's okay to fornicate - as long as they fornicate "responsibly."
- IPPF is the world's largest distributor of condoms and abortifacients to children (without parental knowledge, of course) - and when the condoms and the pills and the IUDs fail, IPPF is there to provide abortions, also without parent knowledge.
- IPPF's roots are Nazi to the core -
  - The group's founder, Margaret Sanger called for "elimination of human weeds" and "more children from the fit, less from the unfit."
  - IPPF's founding guru trumpeted the Nazi call for segregation of "morons, misfits and the maladjusted.
  - She demanded sterilization of "inferior races." And like the Nazis, IPPF's founder preached the need to place "dysgenic stock" in concentration camps.
  - IPPF's Sanger enthusiastically supported infanticide before most people had ever heard of the vile word, saying that "the most merciful thing a large family can do to one of its infants members is to kill it."

**PARTIAL BIRTH ABORTION BAN**

On 7/23/98, the House of Representatives voted 296-132 to override Pres. Clinton's veto of the ban on Partial-Birth abortion.. The Congressional Quarterly reports that Senator Tom Daschle (D.SD) said "the Senate vote was a close call that could not be predicted." The House has 10 votes more than is necessary to override Pres. Clinton's veto while the Senate needs 3 more votes for an override. Please pray for the babies success on this issue.

**CHILD CUSTODY PROTECTION ACT (CPPA)**

On 7/13/98 by a vote of 276-150, the House passed the CCPA which later passed in the Senate. The Act makes it a federal crime to transport a minor over a state line from a state that has parental notification/consent laws to a state without such laws for the purpose of obtaining an abortion. This statute applies to the 29 states that have parental notification laws. Unfortunately, for the youth and families of New York State, this Act does not apply here as we have no parental notification/consent laws.

IN THE WAKE OF PARTIAL-BIRTH ABORTION



On June 29, 1998, a 17-year old girl went to the A-Z Women's Center in Phoenix, Arizona, seeking a partial birth abortion. Arizona law prohibits abortions after 24 weeks gestation without proof of medical necessity. Using ultrasound testing, abortionist John Biskind determined the child was 23 weeks and 6 days old. The following day, the teen returned for the abortion.

In the midst of performing the abortion, Biskind claims he realized the child was much further developed, halted the abortion, and delivered the child. The six pound, two ounce girl survived, but has a cracked skull and facial damage. It has been determined that the girl was really in about her 37th week of gestation. Biskind has been licensed by the state of Arizona since 1981. Arizona's largest newspaper, "The Arizona Republic", reports that he was censured by the state medical board in 1996 for "gross neglect" in the case of a 26-year old woman who bled to death following an abortion. He is also currently being investigated after another patient bled to death from a punctured uterus this past April. He is involved in two lawsuits in Cleveland involving a man who ran an abortion practice after his medical license was removed. The Arizona medical board sent letters of concern to Biskind in 1990 for trying to perform an abortion on a woman who was 28 weeks pregnant instead of the 10 weeks he determined, and in 1991 for inappropriately prescribing medicine.

Let's take another look at this tragedy -

There was confusion as to the gestational age of the baby. Isn't it rather odd that the child was just one day shy of the legal limitations? When money is your God, life has no value. Obviously, we see things differently-even on a sonogram. Suggestions have been made that the abortionist intended to continue the abortion, but the baby's head slipped out. Why is this man allowed to continue his practice? Why not? On October 3, 1973, Kenneth Edelin killed a live infant, not yet delivered from the womb. He had made several unsuccessful attempts to abort the child using the saline method. Finally, he decided to abort the child by hysterotomy. Dr. Giminez, a second year resident who witnessed the abortion stated that Edelin separated the placenta from the uterus, waited a few minutes, causing the child to suffocate, and then removed the placenta and fetus. Edelin was first convicted by a jury but later acquitted by the Massachusetts Supreme Court, which held that since the fetus was not viable, there was no law prohibiting what he did.

More recently, Rosa Rodriguez was born with one arm amputated at the shoulder and deep scalp lacerations after abortionist Abu Hayat "botched" her abortion. These so-called "doctors" continue their butchery with the blessings of the courts. But pro-lifers who peacefully and prayerfully protest these inhumane practices are heavily fined and/or jailed under the RICO Act. Some justice system!

Let's consider fetal pain: Biskind's victim was estimated to be 37 weeks gestation. Forty weeks is considered full term. Noxious (pain) stimuli begins between the 7th and 10th week of gestation. The Trigeminal nerve, the sensory nerve of the face, is already present in a 4-week old embryo.

The little girl had a broken skull and two deep lacerations on her face. Remember, this baby had been pulled by one of her legs, with her head dragging, into position through the birth canal in order to puncture her skull, insert a catheter, and suction out her brain in order to collapse her skull. That would have been fine with the abortionist! What traumatic pain she must have suffered!

President Clinton and Planned Parenthood take note. This can never be considered a justified and medically necessary procedure. Even the American Medical Association disagrees with you. You must share responsibility for this tragedy!

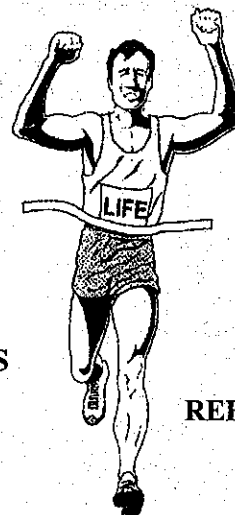

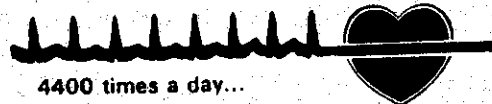

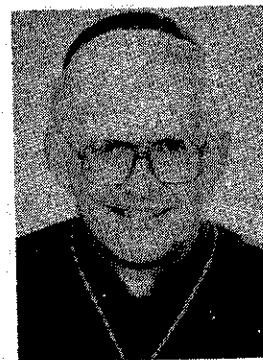
