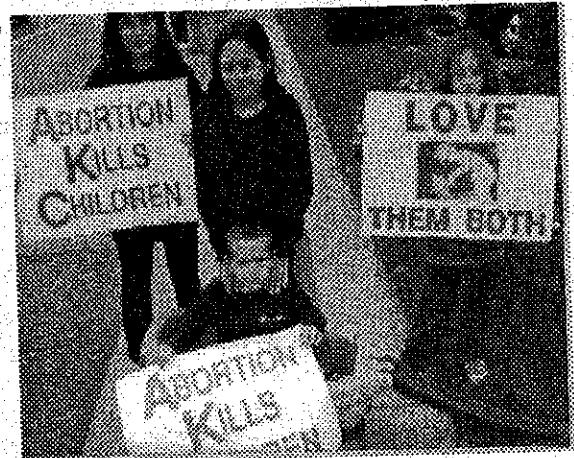
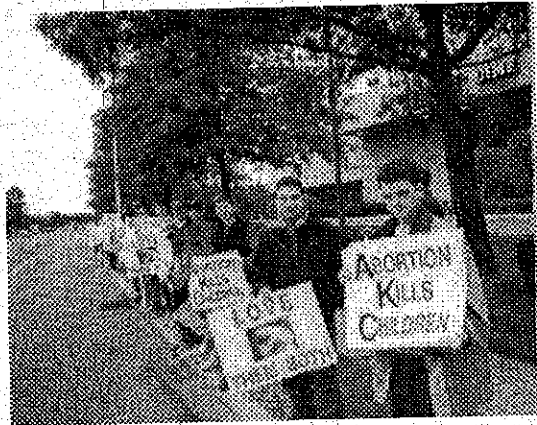

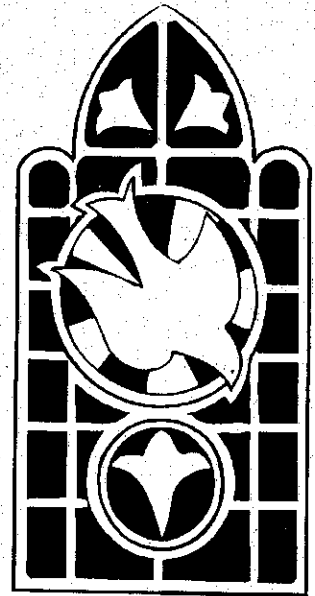

The Society of Centurions by Fr. Frank Pavone ♥ Priests for Life

I often say that I believe in the 'dead-end rule.' This is the rule that says that if you go down a dead-end street and don't see the sign that says it's a dead end, you will soon learn by personal experience that the road is a dead end.

For decades, the pro-life movement has been putting up dead-end signs along the road of abortion. Many choose to ignore those signs; others don't see them at all. But the fact is that individuals who become involved in abortion, and nations which embrace it as policy, eventually learn by painful experience that abortion is a dead end. Just try naming one societal ill which abortion has solved.

There is a special group of people who have come to the dead end and have resolutely begun walking the other way. They call themselves the **Society of Centurions**. They are former providers of abortion who have abandoned that practice and now embrace the sanctity of life. Their number includes physicians, nurses, paramedical personnel, technicians, receptionists, and security personnel. The Centurions from an international society, and a United States branch, the *Society of Centurions of America*, has recently been formed.

Some Centurions speak publicly of their journey into the abortion industry, and how by grace they were rescued from it. But that is not the focus of the Society. The focus, rather, is their own personal healing. Periodically, Centurions from around the world come together, and under the expert guidance of Dr. Philip Ney, a practicing child and family psychiatrist, walk the long and painful road toward healing. Dr. Ney has written a fascinating book, *The Centurion's Pathway*, describing this road. He explains how the wounds of personal abuse often pave the way for a person to abuse others by practicing abortion. He also describes how former providers need to personalize each of the children they have destroyed. Some, for example, will name and even make illustrations of each of the children they were responsible for aborting.

My friend Joan Appleton, who was once the head nurse of an abortion facility in Falls Church, VA and now is on the staff of Pro-Life Action Ministries in the Twin Cities, coordinates the *Society of Centurions of America*. She has recently written an account of her own journey, called *Raising Cecilia*.

The Centurions' brochure puts it beautifully: "The Centurion who stood at the foot of the cross of Christ suddenly became horrified at the crucifixion he was ordered to carry out. When Christ died, this Centurion dropped his sword and fell to his knees exclaiming, 'Surely, this was an innocent man!'" "Those of us who have participated in the killing of unborn children are the Centurions of today. We have dropped our swords against the unborn child. Now we must recognize the depth of our guilt and deal with the ramifications... To revitalize our humanity we need to forgive and be forgiven, to reconcile and be healed." *May it be so, Amen!, Fr. Frank Pavone*

PARTIAL-BIRTH ABORTION A JEWISH PERSPECTIVE

THE INSTITUTE FOR RELIGIOUS VALUES is a new organization, founded last October. On March 13, 1998, seventy rabbis sent a letter to the United States Senate describing their opposition to partial-birth abortion and urging the senate to override President Clinton's veto of the ban. Now one-hundred rabbis have signed the statement. **This is the very first time since Roe v. Wade that there has been any organized effort in the Jewish community against abortion!**

LEGISLATIVE WATCH

The Long Island Coalition for Life wishes to thank the candidates pictured above for accepting the invitation to address our members at the LICL Candidates Night held on Monday evening, September 28, 1998. Persons pictured above will be on the ballot on November 3. While all major parties were invited, no one appeared to speak for the pro-abortion position.

Note: Several other candidates had accepted our invitation but were unable to attend at the last minute. These are: Edward P. Romaine-Suffolk County Clerk; Joseph R. Morning After Pills -- Contraceptive or Abortive?

The U.S. Food and Drug Administration recently approved the use of Preven as the first-ever prescription emergency contraception pill. At the time of this writing, the new kits (cost - \$20.), should be coming into our pharmacies. A Somerville, NJ company, Gynetics, Inc., founded by Roderick Mackenzie, is manufacturing the pills. The regimen consists of taking 2 oral contraceptive pills within 72 hours of unprotected sex, and another 2 pills 12 hours later. The pills contain ethinyl estradiol (estrogen) and levonorgestrel (progesterone). The company claims the pills are 75% effective at preventing pregnancy when taken within three days postcoital.

The big question is - Are these pills contraceptive or abortifacient? Obstetrician Eugene Rudd, M.D., Associate Director of the Christian Medical and Dental Society has identified the morning after pill as an abortifacient rather than as pregnancy-preventing "emergency contraception". "The fertilization of the egg - the moment of conception - typically occurs within the first few moments or hours following intercourse. When these pills are taken - up to 72 hours after intercourse - a human life has already begun."

All emergency contraception pills can work in three ways:

- 1) To thicken the cervical mucus which prevents or delays sperm migration.
- 2) To prevent ovulation by suppression of the critical area of the hypothalamus section of the brain.
- 3) To cause endometrial changes that prevent implantation of the fertilized ovum into the lining of the mother's womb (nidation). This abortive action is always a part of the pill's scope, even when used as a "contraceptive".

Dr. J. Richard Crout, Director of the FDA explains, "fundamentally, these pills take over the menstrual cycle from the normal endocrine mechanisms, and in so doing, they inhibit ovulation and change the characteristics of the uterus so that it is not receptive to a fertilized egg."

Dr. Alan Guttmacher, former President of Planned Parenthood, described the effect of the combined pill on the endometrium as a "picture of exhausted glands...one doubts it could support implantation of a fertilized egg."

The real problem in getting pro-abortion people to admit the abortifacient action of these pills is their use of semantics. Contraception is the act of preventing conception or fertilization. The pro-abortion mentality bypasses fertilization and accepts as contraception all methods that work to prevent a pregnancy and/or terminate a pregnancy up to and including implantation. The tiny growing fetus is referred to as a zygote or blastocyst to avoid associating the action with abortion, which is the premature expulsion of a fetus. The American Medical Association defines abortion as the "premature termination of a pregnancy". However, they define pregnancy as beginning at implantation, not conception. Therefore, they see pills used to destroy the embryo prior to implantation not as abortive but as contraceptive. Amazing what a little game of semantics can do to ease one's conscience!

Jim Sedlak, President of Stop Planned Parenthood Int'l suggests "let us consider not using the terms "early abortion" or "abortifacient" when referring to the action of these birth-control (not contraceptive) products. Let's inform the whole world that these products work by causing the death of a unique human being during his or her first week of existence. This is an accurate description of how the devices work, and even Planned Parenthood is forced to agree. With accurate words, we can engage in the fight and win...What the FDA has approved is the ability for women to kill children in their own home."

Lower dosages are used in these new ECP's in order to lessen the serious side effects. Therefore, it is probable that breakthrough ovulation occurs more frequently, and thus more eggs will be fertilized and aborted.

Judy Brown, President of American Life League said "government agencies will go to any length to pander to the sexually irresponsible...Women will suffer various physical and emotional complications...pre-born children will be destroyed." She has accused the FDA of approving a do-it-yourself abortion kit.

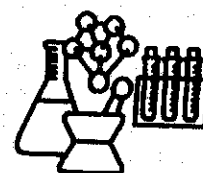
Fortunately, at the present time ECP's are available only by prescription. But in Seattle, pharmacists are permitted to prescribe the treatment. How long before other big cities follow suit?

Life is a continuum - from fertilization, to birth, to natural death. Every stage of development is equally important. Our humanity exists at every stage. We must now speak out to protect the targeted pre-implantation stage.

Bogamir M. Kuhar, Exec. Dir. of Pharmacists for Life says it all, "an early abortion is still an abortion, and no semantics change this reality. (Though for some they do manage to obscure it.)"

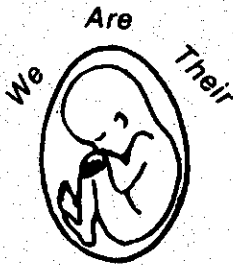

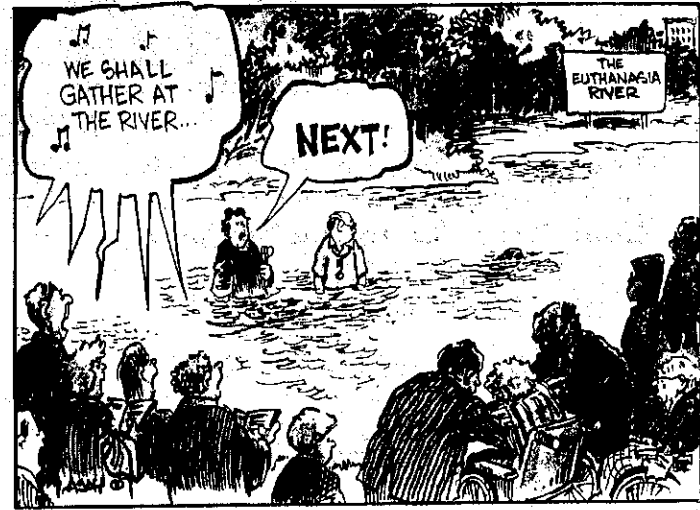

On the advice of doctors, a nurse at a Hospital in New York City had her supposedly **fatally deformed fetus** aborted, only to discover afterward that the unborn child was apparently **perfectly healthy**. 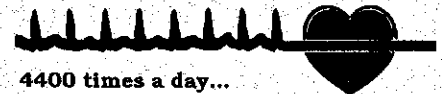

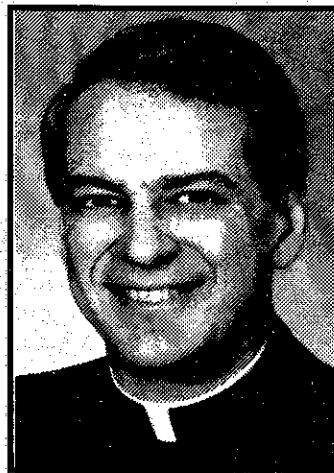
