

INFANT EUTHANASIA

Some Dutch doctors don't agonize over euthanizing the infirm elderly. Many senior patients enter hospitals in the Netherlands with fear that they may not return home alive.

Infirm infants don't stand a chance at surviving. In 1995 about 8% of all infants who died in the Netherlands (some 80 babies) were euthanized by Dutch doctors as a response to the babies' disabilities.

We in the U.S.A. should be outspoken in criticizing the deliberate killing of innocent & defenseless human beings anywhere it is done. God alone gives life and He alone has the authority to take life.

PRO-LIFE LEADER RETIRES

After serving 16 terms and recognized as the leading voice in defense of the unborn, Congressman Henry Hyde (R.Ill.) is retiring this year. Celebrated as the architect of the Hyde Amendment prohibiting our federal taxes from being used for abortion except when the life of the mother is threatened or in cases of rape and incest. Clearly Congressman Hyde was a champion defender of life.

3. The Human Cloning Prohibition Act S.658/H.R.1357 which needs to be passed in both Houses.

NEW YORK STATE LEGISLATION



The 2005-2006 Legislative Session is scheduled to conclude 6/22. In recent sessions there seems to be a "June pattern": Pro-life bills die in committee but at least one anti-life bill advances rapidly. We are being told repeatedly that without constant pressure from constituents legislation that would fund embryonic stem cell research (ESCR) is likely to pass. The pressure from ESCR groups is intense and ongoing. They do not stop at one letter or call. Neither should we.

ACTION

--Write, call or FAX the Governor and your State Senator.

--Arrange a meeting with your State Senator in his district office. Invite several of his pro-life constituents to join you.

LONG ISLAND SENATORS ARE KEY TO STOPPING ESCR FUNDING.

Sample message:

Please oppose any and all state authorization and/or taxpayer funding of human embryo-destructive research or human cloning. In their intensive campaign for embryonic stem cell research lobbyists hide the fact that despite more than 20 years of this research not one human patient has been helped. This was also hidden in the memorandum of A.6300-A which states: "Scientists and researchers working in New York State and around the world are making great progress in the development of therapies to treat and in some cases to cure what were once hopeless and deadly diagnoses." Legislators who voted for this bill which would allocate millions of dollars for embryonic cell research were not told that the "great progress" was due solely to adult and umbilical cord blood stem cell research and that not a single patient has benefited from embryonic stem cells. A.6300-A was rushed through committees and voted on in one day. How many who voted for the bill were aware of its deceptive language?

Please keep New York State a leader in biotechnology by supporting and funding ethical and promising adult and umbilical cord stem cell research. Not only has this research provided benefits in treating 65 diseases, but some recent studies show that these cells have the same flexibility as embryonic stem cells without the problem of tumor growth seen with embryonic stem cells.

The New Partnership - Euthanasia Society and Hospice

The Hospice Patients Alliance's website, www.hospicepatients.org, contains an article by Ron Panzer, President, dated January 30, 2006. Entitled "Dancing with Death", the article reported that "The Euthanasia Society of America later known as Choice in Dying merged with Partnership for Caring (a hospice lobbying group) which merged with Last Acts (a hospice lobbying group) which was absorbed by none other than the largest hospice lobbying group in the USA, the National Hospice & Palliative Care Organization, which represents two-thirds of all hospices in the USA! You don't need to be a conspiracy theorist to know that hospice in America has turned the corner from a life-affirming, compassionate way of serving the dying and allowing a natural death in its own timing, to an agenda-driven, lean, mean killing machine! The dots are connected and there's no denying how the transition occurred. Back door euthanasia is happening throughout our nation, now, already. We need have no fear of "sliding down the slippery slope" toward euthanasia; we're already at the bottom."

Panzer states that even physicians and nurses, who are experienced in the health care field, have been misled, resulting in the death of a loved one in hospice. He goes on to say that palliative care is "now the fast track to a hastened death...being imposed by...terminal sedation: Morphine and Ativan (or their equivalent) plus removal of hydration till you die." This makes the legalization of euthanasia and assisted suicide unnecessary. "It's cheap, convenient, looks outwardly 'peaceful' and allows everyone to lie and pretend that nobody is being killed."

The organization has received a number of reports of patients "railroaded into hospice without their permission, even though the patient is conscious, competent and able to make their own decisions!" Supporters of euthanasia argue that our limited medical funds shouldn't be 'wasted' on these patients. As Panzer states, "the sanctity of life ethic has been replaced with the quality of life ethic."

Andrea Clark is an example of the current climate. She suffered complications after open heart surgery requiring the use of a ventilator and dialysis. Her family stated that her motor control faculties were damaged, but her cognitive abilities were not affected. On April 19, 2006, doctors at St. Luke's Hospital in Houston, Texas informed the family that her medical care would be withdrawn in ten days. The family needed to find another hospital that would agree to care for her. Wesley J. Smith wrote "For years I have been warning that bioethicists are getting their ducks in a row to permit them to refuse wanted life sustaining treatment that is removed because it keeps the patient alive, not because it doesn't provide medical benefit. These are value judgments, not medical determinations...Note that the treatment is apparently being removed because it works, not because it doesn't—which means, in effect, that the hospital ethics

committee has declared the patient's life to be futile." (www.lifenews.com, 'Houston Hospital Planning to Euthanize Patient Despite Family's Wishes', April 24, 2006.)

Steven Ertelt, editor of LifeNews.com, reported that the Terri Schindler Schiavo Center for Health Care Ethics was supporting the Clark family. According to the foundation, "Andrea Clark is not comatose nor is she brain dead and yet, her life hangs in the balance because a hospital ethics committee has decided that her life is not worth living. This case is another example at how we have lost compassion not only for the disabled and elderly but for the medically dependent as well." (www.lifenews.com, 'Legal Battle Heats Up Over Andrea Clark and Potential Euthanasia Death Case', May 1, 2006.)

In a similar case, doctors at the North Austin Medical Center decided to stop providing Lang Yen Thi Vo any medical treatment. They claim she is in a persistent vegetative state (PVS). Her family states that she has been responsive to them. The Medical Center extended its deadline to allow the family time to find another medical facility. The center found a facility in Illinois that would accept Vo. However, her family argues that she is too weak to make the journey, and having her so far away places a hardship on the family. Vo's daughter, LoAnn Trinh, a doctor, said that her mother "wanted to receive lifesaving medical treatment in such a case". Trinh disputes the claim that she is in a PVS, stating that she may be unresponsive to doctors and nurses because she only speaks Vietnamese. She said, "This is not what mom wants, this is not what father wants, and this is not what the family wants. She is not brain dead...To pull someone off life support would be cruel and unusual." Trinh told reporters that she feels money is determining the medical center's decisions. Her mother's Medicare and Medicaid benefits will run out soon. She also stated that "once doctors have made the decision that a patient is beyond hope, it's difficult to find another medical facility to accept a transfer."

The Texas Futile Care law allows doctors and hospital ethics committees to decide the fate of patients regardless of their wishes or those of their families. Wesley Smith states, "Texas has a terrible law that permits an unelected, self-appointed, anonymous ethics committee to forcibly remove care. Once that happens, the patient has 10 days to find another hospital. These are closed proceedings. I am unaware of any records kept of the evidence presented at the hearings or the deliberations. These are life and death decisions and it seems to me that there may be a significant constitutional issue here of immense importance. A law permits private decision-making that will result in death without even the right to a public hearing, to cross examine witnesses, or a formal appeal."

Panzer concludes "We are a sleepwalking nation, dishing out death casually and insanely to those we have a sacred duty to love. There are wars, crimes, starvation and disease threatening to end life at any moment, yet we choose to kill the unborn, the born, the disabled and diseased, the elderly and the weak. Only a lost nation could so actively reject the gift of life! Isn't life precarious enough without seeking to dance with death?"

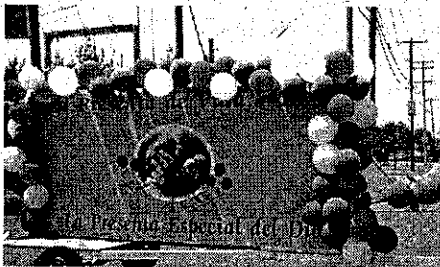

Standup Girl: Take Charge of Your Unexpected

Pregnancy is written by Becky Fraser with the assistance of Linda Shands. This highly readable book is an extension of the hugely successful teenage crisis pregnancy web site of the same name.

If a young girl who is pregnancy Googles "teenage pregnancy" or "abortion", the second link on the right is to www.standupgirl.com. Last year the web page received over 200,000 individual visits each month, with an average stay of 15 minutes.

Standup Girl begins from the time when a girl discovers she is pregnant and then goes through all the options-keeping the baby, telling one's parent, the baby's father, preparing for pregnancy, birth, and parenthood--and every thing in between.

I imagine Standup Girl would be a special blessing to pregnant teenagers, but as an average reader what I took away from it was a blessing all my own. The book was written with a deep compassion for the girls that stems from Becky's own experience with having a baby as an unmarried student.

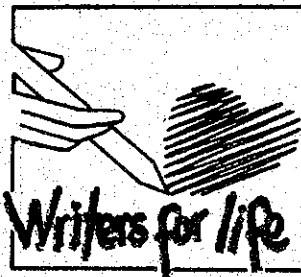

Boycotts are more effective when local store managers and corporate officers hear from consumers who say they are boycotting the company. We thank those who contacted Whole Foods. We urge you to continue to write periodically to remind corporate officers that you have held steady in your resolve. According to the Spring 2006 of Life Decision International's (LDI) *The Caleb Report*, Whole Foods "continues to mislead consumers by pleading innocence and ignorance, but its officers are neither". We do not know if individual stores have the authority and autonomy to prohibit donations to a particular entity. It is likely that local managers are unaware of corporate donations to Planned Parenthood or donations made by other franchised stores. Regardless, all individual stores are culpable by association with the parent company. When LDI finds a company that gives to Planned Parenthood Federation, LDI educates the company about Planned Parenthood requesting it stop giving to that organization. Based on the response of the company, LDI decides whether or not to add the company to "The Boycott List." Whole Foods has not been forthcoming with LDI, which reports that Whole Foods made a donation to Planned Parenthood late last year. 

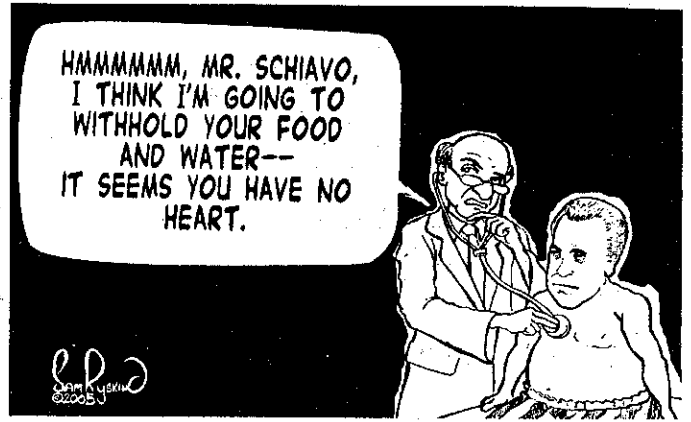
