Prayer and Fasting

Come before work, after work, after church service, with your prayer group, mom's group, elders, lectors. We need men's groups to take the overnight shifts, high school students who need community service hours, youth ministers, college students in between classes, and clergy of all denominations to give praise and worship.

CONGRATS DUE KNIGHTS OF COLUMBUS

The Knights, at their August 2007 Convention in Nashville, passed a resolution officially barring pro-abortion politicians from participation in events sponsored by the Knights of Columbus. The resolution reads: "...We reaffirm our long-standing policy of not inviting to any Knights of Columbus event, persons, especially public officials or candidates for public office, who do not support the legal protection of unborn children or who advocate for the legalization of assisted suicide or euthanasia." The Knights also called for laws protecting medical professionals and Catholic hospitals from acting against their conscience.

The Knights "called for laws protecting medical professionals and Catholic hospitals from acting against their conscience," reports Ms. O'Brien, and "resolved to 'support programs that provide women facing crisis pregnancies with alternatives to abortion, including adoption,' and to 'support projects that provide spiritual support to those women suffering from the traumatic emotional and psychological after-effects of abortion.'"

CIRCUMVENTING THE PBA BAN

Abortionists have modified their technique to kill late term pre-natal babies before partially delivering the babies and smashing their skulls.

The lethal injection method is being used in order to avoid any chance of a live birth or prosecution under the recently upheld federal Partial Birth Abortion Ban Act.

The National Abortion Federation "...has developed a protocol for using dioxin for its members and is providing their training." Three major Harvard affiliated hospitals have made lethal injections in the womb a standard operating procedure for abortions at 20 weeks or later.

HELP FOR PRENATAL DOWN SYNDROME

Sen. Sam Brownback (K.S.R), at a 7/18/07 press conference, brought attention to the fact that 90% of preborn children diagnosed with Down syndrome are aborted. His proposed legislation, the Prenatally and Postnatally Diagnosed Conditions Awareness Act would require that families who receive a diagnosis of Down syndrome or any other condition, prenatally or up until a year after birth, be given up-to-date information about

the nature of the condition and connection with support services and networks that could offer assistance. Sen. Brownback observed, "We as a society must offer as much protection as we can..."

GEORGIA GOVERNOR SHOWING THE WAY

Gov. Sonny Perdue signed into law a bill promoting adult stem cell research. SB148, the Saving the Cure Act, encourages ethical research involving stem cells from the umbilical cord, placental tissue and amniotic fluid which will not result in the destruction of human life.

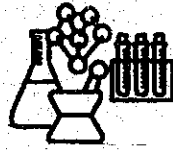

Lack of Ethics



The above title comes from Judie Brown's blog dated September 4, 2007. She was commenting on the report that the Human Fertilisation and Embryology Authority of Great Britain has given initial approval to human-animal cloning. This Authority said that there was "no fundamental reason" to prevent the research proposed by scientists at King's College London and Newcastle University. It further stated, "This is not a total green light for cytoplasmic hybrid research, but recognition that this area of research can, with caution and careful scrutiny, be permitted." The research involves the creation of chimeras – infusing the eggs of dead cows with human DNA. The resulting embryos are 99.9 percent human and would be used for embryonic stem cell research. The embryos would be killed two weeks after creation so that their stem cells can be harvested.

There is a shortage of human eggs due to the low rate of egg donations by women. The procedure involved in extracting the eggs from women is painful and can cause serious medical complications. The British government has proposed legislation that will be debated later this year. This legislation would allow scientists to create human-animal hybrids. The legislation mandates that the embryo be destroyed within two weeks of "creation". Dr. David King, a researcher at the watchdog Human Genetics Alert stated in the Evening Standard, "We are not a pro-life group but creating embryos purely for the purpose of research turns the embryo into nothing more than a research tool and a source of raw biological material for experiments." Judy Brown wrote, "...what this practice actually is, in essence, is the creation of a chimera, an entity composed of genetic parts from diverse organisms. What's interesting about this report, and their lack of the use of the word chimera, is that if you look the word up in your dictionary you will see something absolutely prophetic. Chimera was a monster in Greek mythology that had a lion's head, a goat's body and a snake's tail. As gruesome as that sounds, the proposed new scientific tactic sounds far worse. To put it bluntly, this is one of the most outrageous, sinister plots to neuter the meaning of the human person that I have ever come across. It is nothing short of barbaric; but it is also to be expected in this age when man has replaced God with himself."

John Whitehead, founder and president of the Rutherford Institute, has an article dated September 5, 2007 on LifeNews.com entitled "Blade Runner: What Does It Mean to be Human in an Artificial World?" He quotes Pat Mooney, the executive director ETC, a science

watchdog organization: "For the first time, God has competition." Whitehead states, "...far different than cloning or cultivating stem cells, today's scientists are going beyond replicating life. They're creating life in a lab. The process of creating so-called 'wet artificial life' or 'synthetic life' involves building a living organism from nothing but life's very own basic building blocks – genes. Such scientific tinkering will obviously have revolutionary implications – especially in how we humans view ourselves." Whitehead quotes Professor Arthur L. Kaplan, "When we can synthesize life, it makes the notion of a living being less special."

Whitehead continues, "As we see with recent scientific developments, defining what it means to be human is increasingly the dilemma faced by contemporary society. As such, the most vital question confronting us is how to maintain our humanness in the face of an increasingly dehumanizing world... we have moved deeper into the methodological terrain of a post-9/11 world – one now, more than ever, dominated by technology and an amoral science. And with the daily bombardment of terrorist threats, perpetual wars, global warming alarms, entertainment distractions and a propagandizing media, it is no wonder that only a few realize what is happening to them."
