Doctors Without Borders Teams up with Do-it-Yourself Abortion Group

The humanitarian group, Doctors Without Borders (DWB), launched online medical abortion guidelines that its partner group acknowledges will be used for do-it-yourself abortions.

DWB, also known as Médecins Sans Frontiers (MSF), says it “has teamed up with” HowToUseAbortionPill.org to create an online video guide on how to use pills to abort an unborn child up to 22 weeks. In a cartoon-based guide, MSF shows how to “push out the pregnancy,” in “a process that is similar to miscarriage.” MSF says its “goal is to ensure that everyone” can get the information “no matter who you are, where you are.”

“The fact that DWB is a recognizable, reputable group also might make people more comfortable with the procedure,” an unidentified representative of HowToUseAbortionPill.org said in an interview with Vice President Pence. “We do not see this piece as an instructional guide for self-managed abortion,” she said of the video. “However, we know that much of our online content...is used for self-managed abortion.”

HowToUseAbortionPill.org alerts users to the fact that the US FDA has made it illegal to sell the abortion drug mifepristone online or in pharmacies, that five U.S. states have made self-induced abortions illegal, and 18 states prohibit telemedicine abortions. The website calls itself “an online community run by dedicated individuals who believe that all women, regardless of where they live, should have access to a safe abortion option.” There is no information giving the names of its staff, an address, or who funds the website.

The HowToUseAbortionPill.org program manager said that, “because the how-to videos are available to the general public in multiple languages,” the MSF guide, ostensibly meant for health professionals in humanitarian settings, “can double as a complete guide to doing your own abortion, outside of medical supervision.”

DWB/MSF is a critic of the U.S. Mexico City Policy that bans taxpayer funds for promoting or performing overseas abortion. The group says it does not take U.S. funds, and that it is not affected by the policy.

“You don’t need any advanced technology or specialized medical interventions in order to provide medication abortion safely,” the MSF website says. “All you need” are information, medications, and “mutual respect and trust,” and for that reason, abortions have increased “for millions of women and girls around the world—and especially in low-resource and humanitarian settings.”

Children born prematurely at 22 weeks have survived outside the womb. DWB/MSF warns humanitarians in the video guide that if the child makes noise or moves after the abortion, it could be upsetting for the woman who has aborted the child. It says that the woman may want to hold the aborted “pregnancy,” take it home, and even give it a burial.

MSF does not list abortion among its humanitarian services on its website, but says it is part of its maternal health program, arguing that “unsafe abortion” is the fifth leading case of maternal mortality after postpartum hemorrhage, sepsis, complications from delivery, and hypertensive disorders. “Of all these, unsafe abortion is the only one that is completely avoidable,” the MSF website says. It does not say list avoiding abortion as a way to avoid maternal deaths.

“As we continue to participate in sessions and keynotes at the UN this week, the YWCA is also advocating for specific priorities for countries attending the CSW, including the promotion and protection of all human rights and fundamental freedoms, access to sexual and reproductive rights and services, the end of forced childhood marriage, increased intergenerational leadership and the elimination of discrimination against women.”

More recently, the YWCA issued its position on the nomination of Judge Kavanaugh. “YWCA USA strongly opposes the nomination of Judge Brett Kavanaugh for U.S. Supreme Court” (7/9/2018) (www.ywca.org/blog/2018/07/09/ywca-usa-strongly-opposes-the-nomination-of-judge-brett-kavanaugh-for-u-s-supreme-court)

“Kavanaugh’s record demonstrates a blatant disregard for the rights of women, workers, immigrants, and consumers. His nomination is a direct threat to all reproductive rights, particularly *Roe v. Wade*. He has stood firmly against women’s constitutional rights, including trying to block a young immigrant woman from exercising her constitutionally protected right to an abortion.”



FEDERAL LEGISLATION

The U.S. Senate held hearings Feb. 11 on the need for the *Born Alive Act* [S.311]. With no specific law to ban taking a born-alive infant's life, there have been no prosecutions under the 2002 *Born Alive Act*. Senator Mike Lee said, "I'm aware of no other circumstance in the law where we'd willfully disregard the humanity of a human being." The CDC said from 2003-2014, there were 376-588 deaths of infants born alive after "termination of pregnancy," 143 "definitively" after abortion attempts. They note that Gosnell was responsible for well over 143 spine 'snippings' but didn't report even one. The ACLJ estimated there are 44,000 abortion survivors living in the US today.

On Feb. 25, the Senate voted on two pro-life bills - the *Pain Capable* (20-week) abortion ban [S.160], and the *Born Alive Act* [S.311]. Few Democrats attended the pre-vote 'debate', where [S.311] sponsor Sen. Sasse said "...We're talking about babies that have already been born. Nothing in this bill touches abortion access." The *Pain Capable* bill was voted on first. When it was a Democrat's turn to vote, they walked into the 'well' of the chamber, and gave a 'thumbs down' or a loud "No." The tally was 53-44, mostly along party lines, but 7 short of the 60 votes needed to pass. (Democrats Casey & Manchin voted *yea*, GOP's Collins & Murkowski - *nay*)

The scene was repeated for the vote on the *Born Alive Act*, except *Grassfire* reports a few Democrats were seen "Hi Fiving" each other following their vote. The tally was 56-41. (Democrats Casey, Jones & Manchin voted *yea*. No GOP *nay* votes. Klobuchar, Sanders, & Warren did not vote on either bill.) [see *lifeneews.com*, Feb. 25, 2 articles]

On Feb. 28, GOP Reps made an 81st attempt to get a House vote on the *Born Alive act*, [HR.962], by trying to attach it to another bill, HR.2339. It failed 220-187. Democrats Lipinski, McAdams, & Peterson voted *yea*.

On Feb. 13, as 2,411 fetal remains left by abortionist Ulrich Kloper were being buried in Indiana, Rep. Jackie Walorski (R-IN) had the House honor them with a moment of silence. She has introduced [HR.4934/S.2590] the *Dignity for Aborted Children Act*, to require respectful treatment of aborted fetal remains.

Also, on Feb. 13, the House passed H.J. Res.79, to try giving states extra time to ratify the 1972 Equal Rights Amendment. Supporters say ERA will 'entrench legal abortion'. The vote was 232-183. [Meeks, Rice, Suozzi - *yea* ||| King, Zeldin - *nea*]

Family Research Council warns the *Fairness for All Act*, HR.5331, is a 'lite' version of the *Equality Act*, except it offers minimal protection for religious organizations, (not individuals) and doesn't gut the Religious Freedom act. The *Palliative Care and Hospice Education & Training Act* passed the House in 2019. Wording of the pending Senate version [S.2080] has been changed to allay the fears of some groups that the bill will push people into hospice too soon. Religious, medical and pro-life groups are divided as to whether the changes address the areas of concern. (See *lifesitenews.com*, Feb 27 & LN, Mar '20, p3)

JUDICIAL

On March 2, SCOTUS said it will hear (next session, in October) the Democrats' case against the 5th Circuit ruling that ObamaCare is unconstitutional. [See LN, March '20, p3]

On March 4, SCOTUS heard *June Medical Services LLC v. Russo*. (formerly *v. Gee*) (See: LN, March 2020, p.3). During the hearings, Sen. Schumer made threats to Justices Gorsuch and Kavanaugh while addressing pro-aborts outside the Court.

The 9th Circuit Court ruled the *Protect Life Rule* can stay in force while a multi-state suit against it continues.

FEDERAL ADMINISTRATION

*The Administration submitted its FY 2021 budget. It ends funds to UNFPA, and PP funding via Depts. of Labor and HHS. *Title X* and Medicaid funds are banned from certain abortion providers. (Congress will modify the budget.)

*NIH's *Human Fetal Tissue Research Ethics Advisory Board* is seeking nominations for the 15 people who will be on the Board. (See: www.lifesitenews.com, 2/19/20)

*The Administration announced that 27 countries have joined the US in a new *International Religious Freedom Alliance*, to push religious tolerance and fight religious persecution.



NEW YORK STATE LEGISLATION

The Democratic Presidential Primary in NYS is April 28. As of March 1, all Democratic presidential hopefuls supported abortion up to birth, with few if any exceptions. The NYS 12th Assembly District has a Special Election on April 28 as well.

Doctors & Nurses rallied in Albany Feb 4, opposing efforts to legalize Doctor Assisted Suicide in NYS.

Gov. Cuomo strongly backs Contract Surrogacy. It would increase IVF, demean woman as 'rent-a-wombs', and turn gestation and birth into 'production of a consumer product.'

A bill has been introduced (A.8743-Epstein) to force all SUNY colleges to make the abortion pill available to students. A tax-deductible fund would pay for the pills.

Judicial Watch has a Voter Guide available with 8 steps to take to help stop voter fraud. Steps include: become a poll worker/watcher, request local voter registration rolls to find irregularities, attend Election Board hearings, write Letters to the Editor/Opinion Pieces, create your own blog/comment on other blogs. Incrementalism and Euphemisms



Judie Brown, President and Cofounder of American Life League, reflected on Incrementalism in her Commentary column on March 6, 2020. The dictionary defines incrementalism as “a policy or advocacy of a policy of political or social change by degrees: gradualism.” Brown noted, “on the downside, we know that, when it comes to abortion, political incrementalism has become a game of choosing which babies will live and which will die. It is all about what the politicians will support. Ever since the Hyde Amendment was weakened with exceptions for rape and incest, the exclusion of some babies has become the political norm. Rape, incest, life of the mother, and often fetal abnormality are the political salve elected officials require so that their votes qualify as pro-life. Yet even worse than this callous disregard for the lives of babies deemed expendable is the fact that the lasting effect of political incrementalism seeps into every aspect of our struggle to defend life.”

Examples of this gradual change in outlook are the ways some medical professionals, ethicists, and a significant number of the general population now view young children with severe disabilities who are struggling for life. There are those who feel the children would be “better off dead.” Medical personnel “claim that [the child’s] struggle for life creates emotional pain for them.” Another example given is the “challenge of treating extremely ill patients who are confronting death. Shockingly, one death with dignity expert in Oregon said: “Death with dignity and palliative care are not two separate things. They actually work together.” Brown responded, “Please note that ‘death with dignity’ is a nice turn of phrase that actually means imposed death on the vulnerable. So what this professional is saying is that incrementalism has also crept into healthcare for the aged and suffering. While you and I might think of palliative care as pain relief, these death mongers use it as a relief from life.”

Brown noted that “assisted suicide and other forms of euthanasia are spreading incrementally across our nation.” She referred to a recent headline in the NY Daily News which stated, “Death with Dignity legislation gets new life in New York.” She commented, “The irony in that headline should not surprise you, because incremental acceptance of killing is growing in popularity from man’s biological beginning until his death.” At first, assisted suicide laws were limited to those who were diagnosed with a terminal disease and less than six months to live. Gradually the net has grown worldwide to include the mentally ill, those suffering from depression, young children suffering from debilitating conditions, and even patients with treatable diseases.

Brown highlighted an opinion piece by Dr. John Goodill (Delawareonline.com, 1/20/20) who wrote,

“Control over the manner and timing of a person’s death has not been and should not be a goal of medicine.” But according to Brown, “there are far too many involved in the practice of medicine who disagree, thus threatening the lives of preborn babies, embryos in the research lab, newborns, and aging individuals. Imposing death seems to be incrementally coming into vogue as the new normal.”

A reference to Hilaire Belloc’s poem “Jim” is made. In the poem, a boy named Jim “never listened to reason, never paid attention to the rules, and constantly ran away from those in charge of his care.” A lion pounces on the boy and begins to attack him, starting at his toes and moving to his heels, ankles, shins, calves, knees. Brown noted, “As a society, we have encountered that voracious lion as well. It is known as the culture of death, and slowly but surely those who advocate for its teachings are hungrily eating away at the moral fiber of our nation – person by person, attitude by attitude, exception by exception. The question is, can we stop it? The answer is, of course we can... Step by step, we teach that fundamental truth: Choose life and do it without exception!”

Hendrik van der Breggen wrote an article on the pros and cons of euthanasia on his blog (2/18/20). [Note: The cons outweigh the pros.] His first point was that ‘medical assistance in dying’ is a euphemism and is “misleading at the get-go. When certain words are considered too blunt, harsh, painful, or offensive, people sometimes substitute a euphemism, that is, a more acceptable term, a term with fewer negative connotations or with more positive connotations, than the blunt, harsh, painful, or offensive term... Euphemisms are sometimes helpful... but they can also desensitize us emotionally and hide reality – including moral reality. Interestingly, the dangers inherent in euphemisms were almost prophetically envisioned by George Orwell in his famous novel *1984* and in his lesser known essay “Politics and the English Language.” Orwell put forward the idea that an effective mechanism of political control is the manipulation of euphemisms employed in public discussion.”

Van der Breggan acknowledged that we all want medical help when we are dying: “clean sheets, proper nutrients, and morphine (as needed) as we die. Please, doctors and nurses, provide us with comfort as natural death takes its course.” However, MAiD “involves actively causing death – killing. Dying and killing are not the same. It’s important to be clear about this distinction and not be bamboozled by euphemisms.”

Catherine Glenn Foster, President & CEO of Americans United for Life stated, “We get to choose one: suicide prevention, or suicide advocacy. We can’t have both... [The] embrace of suicide by physician imposes a regime of suicide advocacy upon the people. There will be deadly pressure on the marginalized, the economically fragile, and the socially vulnerable to make a life-ending decision in a context ultimately devoid of real choice. Every advance of suicide advocacy is a failure of equality under the law, because it makes citizens fundamentally unequal based on their situation.”

GUIDELINES for PRO-LIFE PRESENCE at PRO-LIFE EVENTS and ABORTIONIST’S SITE

All public pro-life witnessing **MUST BE PEACEFUL**. This is legal nonviolent direct action.

Public pro-life outreach is a statement on behalf of all of the victims of abortion.

Your participation in a public pro-life awareness event or your presence at an abortion “clinic” or abortionist’s office is an important affirmation of LIFE, exercise of your Constitutional right to free speech and assembly, and a witness against the tragedy of abortion. You are the face of the unborn.

Babies are dying at the hands of abortionists and their staff. Treat the site appropriately. Eating, loud talking and laughter are out of place.

→ Stay on sidewalks (public property). Do not go on the facility’s property or parking lot.

→ Do not impede access of cars to/from driveways or pedestrians to doors or along sidewalks.


- Stay with a partner. Carry a camera and cell phone.
- Hold signs so they can be read by vehicle and/or pedestrian traffic. Don’t wave signs in front of traffic. Hold signs tightly; larger ones should have handles or string to loop over the neck.
- Carry a pro-life pamphlet/card with pro-life assistance contact info.
- Praying, singing, and Scripture reading should be done without disturbing other pro-lifers who aren’t joining your group.
- Do Not Shout – at patients, workers, residents, those driving by, police, etc. Keep an arm’s length away from them and step away from potential confrontations. Calling out to abortion-bound parents should be limited and done prudently; even though you’re saying something positive, the stressed client may only “hear” negative screaming at her.
- Do not shadow (follow along closely) pedestrians.
- Respond to hecklers gently or not at all. Leave them with a positive life-affirming comment

Your prolife witness is seen by those contemplating abortion, those who know or will know someone with an untimely pregnancy, and those hurt by a past abortion decision. Your presence is critical in keeping the plight of the unborn on the public conscience and saving lives.
