### LICL May 2015 Postcard Project Reaches Thousands

The LI Coalition for Life continues to look for ways to bring the pro-life message directly to residents of our communities. So in late May, we mailed postcards to 20,000 Nassau County households with a resident of college age. The pro-life message on the postcard was meant to be thought-provoking and educational. It also included contacts for pro-life resources. Instead of hoping the addressee would open a letter, using a postcard got our message to him/her immediately. No doubt many of those who read the postcard rarely see or hear a pro-life message.



This project was a significant way to expand our outreach in making more people think about the plight of the unborn. The project utilized the services of a mailing list company (we don't buy the list; we make selections based on various demographics which can be changed for future mailings). This new undertaking was possible through the generous support of our donors, whom we thank very much on behalf of the unborn babies we strive to protect.

**Revisiting the Girl Scouts of the USA's ties to Planned Parenthood.** *Life News* May, 2013 warned of ties, on a national level, between the Girl Scouts of America and the Planned Parenthood organization. The recent videos, see page 3 and 4 of this issue, are a strong reason for parents to investigate and spread the word if their local Girl Scout Troop is promoting the Planned Parenthood agenda even if their child is not a Girl Scout. While some local troops do not embrace the Planned Parenthood agenda there are some that do. In a national survey taken several years ago, and printed at *LifeNews.com* 2/17/2014, 17 councils admitted to partnering with Planned Parenthood, 49 reported they do not, and 249 councils refused to disclose any relationship. A pro-life alternative to Girl Scouts is American Heritage Girls, founded in 1995, and they now have 40,000 members. A local group is located in Merrick, NY. The American Heritage Girls website ([americanheritagegirls.com](http://americanheritagegirls.com)) offers information on starting a group in your area.



## FEDERAL LEGISLATION

On July 14, the *Center for Medical Progress* (CMP) began to release a series of covert videos, wherein top Planned Parenthood officials (among others) discuss ongoing activities, which CMP alleges violate laws against the following:

- a) Sale of aborted baby parts for profit. (PP says the “tissue” is *donated* for research, with consent form. The fee being discussed is just shipping & handling).
- b) Changing the abortion procedure to keep desired parts intact, including doing (banned) partial birth abortions.
- c) Law says abortionist can’t know which babies are to be used as donors.

On July 28, L.A. Superior Court blocked the release of a CMP video alleged to show StemExpress (middle-man between PP and researchers) workers discussing having gotten an “intact” (whole) fetus. Was it a miscarriage, an induced stillbirth, or a botched abortion, left to die???

A commonly heard reaction in news media went like - “no matter your opinion on legal abortion, the people in the videos seem callous” (PP apologized for that ‘tone’). PP claimed “the videos are heavily edited,” de-listed 38 donor companies (including Fannie Mae) from their website, and hired a ‘crisis-management’ specialty firm. A flurry of lawmaker activity ensued. House committees have launched investigations of PP. Senate members disagreed on how best to defund PP. An attempt to attach a defund amendment to a highway bill received only 3 votes.

**On Aug. 3, the Senate failed to pass a stand-alone defund bill, S.1881, (53-46. Need 60 to pass). (Note that S.1881 would *shift* all funds to non-aborting medical providers). Majority Leader McConnell voted *Nay*, which lets him call another vote on the bill at a later time. The White House says it will veto any defunding.**

Looming Oct. 1 is a “Continuing Resolution” to keep all government programs going. Eighteen House members say they will not pass any CR that funds PP.

On July 27, Rep. Lamborn [R-CO] introduced the *End Trafficking of the Terminated Unborn Act (HR 3215)*, to ban taking human body parts from abortions for research.

**H.R.2972** - the *Equal Access to Abortion Coverage in Health Insurance Act* is in committee. It would allow Medicaid to pay for abortions. House Members Israel and Rice are cosponsors.

## NEW YORK STATE LEGISLATION

**Update: Assisted Suicide Legislation,** discussed in the June and July/August issues of *Life News*, were not voted on. These bills remain active for the 2016 Session.

**Update: Nine of the Women's equality bills passed in 2015** but Abortion Expansion did not pass.

In 2013, Gov. Cuomo put forth a 10-point plan that included as a centerpiece expansion of late-term abortion. However, after strong opposition from pro-life New Yorkers, the governor broke the bill up into 10 parts, urging the legislature to take them up individually. Three times, the state Senate overwhelmingly passed the other nine measures, which included bills to help victims of human trafficking and domestic violence, etc.

For two years the Assembly refused to pass the individual bills. With constant prodding from individual Assembly members such as Amy Paulin (D-Scarsdale), herself pro-abortion but a strong supporter of protections for human trafficking victims, the individual bills were brought to the floor and passed.

**The Assembly passed the individual abortion expansion bill, but the Senate did not.**

**NYS rejects “Choose Life” License Plates** - The 2nd Circuit Court of Appeals has ruled that New York State could ban "Choose Life" license plates as 'patently offensive.' However, other potentially controversial plates have also fallen under this ruling, such as "Restore the Wolf" and "RU486." Make of this ruling what you will. NYS claims that it wishes to avoid advocating controversial issues on official license plates.

## HEALTH & SCIENCE

### Planned Parenthood



On August 7, 2015, the Center for Medical Progress (CMP) released the full, uncut video of the undercover visit to the Planned Parenthood abortion facility in Houston, Texas. The video includes a conversation between Melissa Farrell, Director of Research for Planned Parenthood Gulf Coast, and two CMP actors posing as representatives of an organ procurement company which focused on potential compensation to Planned Parenthood in exchange for fetal remains. Cheryl Sullenger wrote at [www.LifeNews.com](http://www.LifeNews.com) on August 7th, "Farrell made it clear that Planned Parenthood had been involved in the selling of aborted baby parts for some time and was very familiar with the use of fetal remains in the production of humanized mice. She discussed how the Houston affiliate for which she worked was "resistant" to recent efforts by Planned Parenthood Federation of America to standardize fetal tissue sales throughout the participating affiliates because "we've been doing our own thing for a long time."...[Farrell] emphasized repeatedly that she creates a written line-item budget for compensation that effectively conceals the fact that the money received from fetal remains is actually a financial benefit to the company above and beyond hard costs. In addition, she noted that they are able to alter abortion procedures to make sure they have body parts to sell. [Farrell stated] "And we have had studies in which the company, and or in this case, investigator, has a specific need for certain portions of the parts of conception and we base that into our contract and our protocol that we follow this, so we deviate from our standard in order to do that." Sullenger continued, "Yet Farrell acknowledged that it was illegal for them to alter the timing or manner of the procedure for the purpose of ensuring organs were fit for use by researchers...One actor posing as a potential buyer asked, [regarding requests for cadavers and fetal tissue to generate humanized mice for immune-deficiency experimentation and the development of pharmaceuticals] "So they are requesting just liver or liver, thymus? Liver, thymus, long bone?" Farrell replied, "Everything! CNS, brain, kidney, thymus, liver, spleen, femur, bone marrow, hematopoietic stem cells, from 14-22 weeks gestation."

Dr. Charmaine Yoest, President and CEO of **Americans United for Life**, stated in a **Media Alert** dated 8/4/15, "Planned Parenthood's spin in trying to push back against the horrific images of picking through the bodies of aborted infants falls flat and misses the point...Planned Parenthood tries to talk about expenses or continues to insist that the videos have been edited to indict them--an odd claim since the full videos, and

transcripts, are all available online. But the broader context of each one of the videos released so far, and the ones to come, reveals a deepening morass of moral, ethical and legal entanglement for Planned Parenthood, including possible infanticide. They may end up wishing the story were only a debate over profit. The videos raise serious, on-going and legal questions about Planned Parenthood's business model. They must be held legally accountable."

Yoest continues, "The videos raise numerous questions of significant illegalities which must continue to be investigated, including: How much money is being exchanged for [baby parts]? Are interstate commerce laws being violated in the transportation of baby parts? Are mothers fully informed, and do they give legal consent to the sale of the babies' hearts, livers, and lungs? Is the illegal Partial Birth Abortion procedure used in an effort to gain valuable later-term, more fully formed heads and hearts? Is the Born Alive Infant Protection Act violated in an effort to gain valuable later-term, more fully formed heads and hearts? Are women encouraged to endure dangerous late-term abortion procedures by abortionists who know that body parts from more developed infants sell for more money? Are federal funds used to subsidize any of the facilities or procedures used in 'harvesting' fetal tissue after the abortion was performed?"

Former Planned Parenthood director Abby Johnson stated in an interview with the Washington Times, "The law currently states that there can be moneys exchanged as long as they fit under certain categories like preservation, collection, storage, transport, etc. And the law says there is not a maximum amount that can be charged or a minimum amount but that costs cannot be prohibitive. And that's very subjective...That's really where we need reform." As of 7/31/15, twelve states have launched investigations. On 8/3/15, the US Senate failed to obtain the 60 votes required to pass cloture on a bill to defund Planned Parenthood. (Sarah Zagorski, [www.LifeNews.com](http://www.LifeNews.com), 7/31/15)
