**The denial of treatment bills that we have been anticipating were filed. PLEASE call your state senators. If he/she is a Republican - let him/her know that we are facing danger because the REPUBLICAN chair of the Senate Health Committee - Kemp Hannon - has introduced these bills. We need all Republican Senators to call Senator Hannon and let him know that they cannot vote for potential euthanasia-related bills. The pro-life vote is a vote AGAINST these four bills.**

**The bill numbers and sponsors:**

**BILL S 4796-2015** (Hannon)/A 6966(Gottfried), related to Do Not Resuscitate (DNR) orders

**BILL S 4794-2015** (Hannon)/A 674(Rosenthal), related to starvation and dehydration of a patient

**BILL S 4795-2015** (Hannon)/A 2775(Pretlow), related to overriding family direction for treatment

**BILL S 4791-2015** (Hannon)/A 6936(Clark) [related to parental notice before a minor child is denied treatment](#)
