Dear Defenders of Life:

Governor Hochul Must Veto Assisted Suicide Legislation

It is deeply concerning that the New York State Legislature has approved a bill to legalize assisted suicide.

THERE IS HOPE!

The Medical Aid in Dying Bill has not yet been signed by Governor Hochul. Governor Hochul may advocate for suicide prevention, but she needs our encouragement to hold consistently to that when it comes to assisted suicide, or Medical Aid in Dying (MAiD). When asked specifically about the bill, Governor Hochul indicated that she had not made up her mind!

We urge a VETO of this dangerous legislation.

Despite strong opposition from disability rights advocates, mental health professionals, and community leaders across the state, the so-called "Medical Aid in Dying Act" (MAiD) passed both the Senate and the Assembly last June.

If signed into law, this legislation would fundamentally alter how New York cares for people who are seriously ill, elderly, or living with disabilities — and it would have lasting implications for future generations.

The final decision now rests with the Governor.



Urge NY Governor Kathy Hochul to Veto Assisted Suicide!

Perhaps in anticipation of the upcoming election, the Governor has not yet signed the legislation. However, she recently broke her silence, stating that she is still considering the matter. The Governor's hesitation means there is still time and potentially a critical opportunity for pro-life New Yorkers to make their voices heard.

 2. State that as a New York voter you do not want Governor Hochul to sign the "Medical Aid in Dying Bill" because it is flawed legislation.

- It goes against the "Americans with Disabilities Act".

- It will affect vulnerable groups like the elderly, the poor, minorities, & those without healthcare may be pressured or coerced.

- It will normalize suicide and can apply to people who, with appropriate treatment, can live full lives for years.

- Know the American Medical Association (AMA is no friend of pro-life causes) also opposes Assisted Suicide.

- If you can, mention a relationship you have to someone who could be affected.
