FEDERAL LEGISLATION

HR.3985, a Federal bill to ban abortions when a fetal heartbeat is detectable, has been reintroduced, and sits in the Judiciary Committee, which has no L.I. members.

HR.3243/S.1168, the *Equal Campus Access Act*, would withhold some federal funds from colleges that discriminate against campus religious groups.

As of Sept. 6, there had been no further action on the *Born Alive*, *Equality* or *Women's Health Protection* Acts.

On Aug. 15, the Dept of Labor released new rules, that make it clear Federal contractors can use reasons of conscience in their decisions to hire or fire workers.

In July, Secretary of State Pompeo & HHS Secretary Azar sent a letter to foreign governments asking for support for the US pro-life position at September's UN Global Health Summit.

The HHS Office of Civil Rights is investigating a claim by a nurse who said she was 'tricked' into assisting with an abortion. She said she was told it was a procedure following a miscarriage. The University of Vermont (where the incident occurred) is challenging HHS' authority stating their policy "strikes the appropriate and legal balance between employees' religious rights and patient care.)

Mary Ann Glendon heads the new Unalienable Rights Commission, announced in July. [see: LN, Sep '19, p3]

The Courts

A non-life-issue case with wider implications is a case concerning a NYC Gun Law. Several top Senate Democrats filed an *amicus* brief in the case, urging the Supreme Court to "heal itself" of "the influence of politics", or face restructuring; i.e.: up to 6 more Justices. (See LN Dec 2018, p3, re: Justice Kavanaugh confirmation)

David Axelrod warned the fight over the next SCOTUS vacancy will "tear the country apart" if the GOP, which did not give Garland a vote in the last year of Pres. Obama's term, tries to fill the seat in a Presidential election year. Sen. Mitch McConnell says he would work to fill the seat in 2020.

On Aug. 26, many of the charges against Dave Daleiden and other CMP staff were dropped by Judge Orrick, who said the 1st Amendment shields CMP from PP's damage claims. Preliminary hearings for the pending criminal trial began Sept. 4, where PP abortion providers admitted supplying aborted baby parts.

On Aug. 17, the 9th Circuit Court rejected a bid by over 20 states to delay enforcement of the *Protect Life Rule*, until it is further litigated. In August, Planned Parenthood announced that it would withdraw from the Federal Title X family planning program. They are unwilling to comply with the *Protect Life Rule*, which prevents Title X grantees from co-locating with abortion facilities or doing abortion referrals. Contrary to statements by PP representatives, the rule still allowed PP to talk to women about abortion in a non-directive manner. (Many states, including NY, are working to fund PP in other ways.)

The Texas Civil Rights Project had ex-California deputy Attorney General Maggy Krell (now lead counsel at PP of CA) sue the US Government over border detainee practices. She said PP sent her *pro bono* to Texas because the issue fell within PP's mission to "help families". In 2018, TCRP feted Cecile Richards with their 2017 Social Justice

Award. (NOTE: According to the courts, unadmitted minors must be able to abort.)

Other States

California's Institute to fund embryonic stem-cell research using taxpayer funds has stopped accepting new applications. No cures were developed, and money has dried up.

Sunil Abhyankar, Univ. of Kansas, warns that (ethical) adult stem-cell research is threatened by the many unregulated clinics that offer unproven adult stem-cell treatments.

When a NJ Judge put a stay on the State's new "Aid in Dying" law, *NJ.com* headlined "Judge prevents doctors from helping N.J. patients end their lives."

An Arkansas Federal Judge extended the stay on three new abortion restrictions.

A Florida Appeals Court ruled in favor of the State's 24-hour waiting period law.

International

French doctors euthanized a disabled man, Vincent Lambert. Doctors removed his food and water tubes. His parents and several siblings objected, but they had exhausted all legal options to protect him.

NEW YORK STATE LEGISLATION

As of the end of August, LICL Candidate Questionnaires were mailed to all currently listed candidates on the November 2019 ballot for the following offices: Nassau County District Attorney, Suffolk County Executive and all Nassau and Suffolk County Legislature seats.

Gov. Cuomo has signed *S.1819-Rivera/A.3276-Joyner*, to create a Maternal Mortality Review Board. It includes health professionals, and women prone to higher than average maternal mortality. It will meet twice a year.

The Trump Administration's *Protect Life Rule*, which forces abortion providers to separate federally funded activities from abortion services, has been upheld in an appeals court, and will likely go to the Supreme Court. In the meantime, the rule is having an impact on at least two Brooklyn clinics. The NY State Budget has allocated, but not yet disbursed, \$16 million in funds to make up for the shortfall. In addition, State Sen. Alessandra Biaggi (D) has introduced a bill to create a fund by making optional gifts via state tax returns. Another gift to Planned Parenthood, courtesy of NY Legislators.

“What are they doing with the bodies?”

The August 23rd edition of *ProLife This Week* at American Life League asked, “*What are they doing with the bodies?*” The article noted that there is increased pressure in the United States to lift some of the restrictions on medication abortions (the abortion pill – Mifepristone – RU486). Medication abortion requires the administration of two pills. The first pill, Mifepristone (RU-486), blocks progesterone, the hormone that helps in the development of the lining of the uterus during pregnancy. This lining is the source of nutrition and protection for the developing baby. Essentially, the baby is starved to death. The second pill, misoprostol, causes contractions which expel the baby from the womb. Some former FDA officials as well as medical professionals support more access to medication abortions, including telemedicine abortions (video chat with a ‘doctor’ followed by administration of the first pill in the ‘office’).

Medication abortions result in a dead baby (usually 5 to 10 weeks old). “These dead babies leave the mother’s body in places other than a hospital, a clinic, or medical office... after taking the first pill at a facility, they take the second pill one to two days later – presumably at home or some other non-medical location. So, what do the mothers do with the bodies of these dead babies? The usual answer we get to the question is that they flush them down the toilet. But what then?”

“Recently a STOPP researcher went to her local water treatment plant and asked for a tour of the facility. During the tour, she asked her guide: What do you do with the babies? The guide knew she was talking about the bodies of babies flushed down the toilet who would travel through the sewer system and wind up at the treatment plant. He said, the bodies get caught by the screening system in the plant and are taken, along with other debris, and dumped in a local landfill. Medication abortions are becoming the largest method of abortion in the United States. Hundreds of thousands of babies are aborted at home every year. It appears that most of their bodies wind up at the sewer plant and treated as just some kind of debris. Most states have laws governing the disposal of fetal remains, but we have not, yet, found any medication abortion provider that tells the woman that they are expected to follow those laws to dispose of their baby’s body.

“Whenever you hear anyone talking about medication abortion and how it is growing in use and should be made more available, ask the question: What are they doing with the bodies? When you get a blank stare, ask again: What are they doing with the bodies? We try to stop as many abortions as possible, but when one does happen, we should know the answer to the question: What are they doing with the bodies?”

In-Utero Blood Transfusion

The Society for the Protection of Unborn Children reported on 8/26/19, that an unborn child, Edward, had developed anemia in the womb. A doctor used ultrasound to insert a needle through the uterus and into the umbilical cord. The boy received 5 blood transfusions before he was born. Michael Robinson, Director of Communications for SPUC Scotland noted that “the option of in-utero surgery, which can save and improve the life expectancy of unborn children, is becoming a far more positive prospect. Currently, in-utero surgery can treat a number of fetal health conditions including Spina Bifida, fetal tumors, Cerebral Palsy, fetal cardiac conditions and Hyperthyroidism.”

In May doctors “performed key-hole surgery on an unborn baby with Spina Bifida, which was the first operation of its kind in the UK. Unborn baby Jaxon received the operation at just 27 weeks gestation, and as a result had the ability to move his legs after being born six weeks later. Similarly, unborn child Ethan Leibbrandt underwent in-utero surgery to remove the benign tumor which consumed 50% of his lung space. The in-utero surgery was successful and life saving as without it, Ethan would have died of cardiac failure.”

Robinson concluded, “The early interventions that can now be used to treat and save unborn children are truly astonishing. The story of Edward once again proves that science is on the side of the pro-life movement. Indeed, scientific developments and new technology is now instilling a sense of awe that society never really had before, about the beauty and dignity of every unborn child. This case illustrates the terrible irony that medical teams spend enormous effort, time, and money to deliver babies safely and nurse premature infants back to health. Yet, in the UK we routinely and deliberately end the lives of 600 babies a day. Whilst pro-abortion campaigners insistently refer to unborn children as ‘blobs of cells’ or ‘parasites’, the use of in-utero surgery highlights that unborn children are human and worth saving and protecting.”
